Commentary

Recommendation

The Law and Order Committee has examined the Juries (Jury Service and Protection of Particulars of Jury List Information) Amendment Bill and recommends that it be passed with the amendments shown.

Introduction

The Juries (Jury Service and Protection of Particulars of Jury List Information) Amendment Bill is divided into two parts. The aim of Part 1 is to improve the administration and integrity of the jury system, and that of Part 2 is to help to maintain the privacy and security of jurors, while still upholding the right of defendants to challenge potential jury members.

Excusals from jury service

Proposed new clause 15A(2) provides that a Registrar must permanently excuse from jury service those aged 65 years or over who request such an excusal in writing.

Some concern was expressed to us that making such a provision available would perpetuate the stereotype of age as a form of disability and thus discriminate against older people.

The Labour members are concerned that extending the Registrar's power to grant permanent excusal solely because a person is 65 or over is at odds with progressive measures advanced over recent years to eliminate ageism and stereotypes, and to promote participation.

We note, however, that the bill does not propose to reintroduce an age limit for jury service, and that those aged 65 years and over would retain all their current rights in relation to serving on a jury. The amendment would allow people in the specified age bracket who no longer wished to be available for jury service to make one request for permanent excusal, rather than a separate request each time that they were summoned, which is required at present.

We do not consider that what is proposed implies that older people are less capable of serving on a jury. On the contrary, we consider that the life experience of older people is of significant value to society and we would encourage those who are able to do so to continue to undertake jury service.

After considering this issue, we do not recommend any amendment to the proposal in the bill to offer older people permanent excusal. At the same time, however, we note that there is currently no mechanism to allow those who choose permanent excusal to opt back in at a later date if they should change their minds.

Jury panel information

We recommend an amendment to clauses 16(2) and 17 to allow a Police employee to access the jury panel or the protected particulars of a jury panel only if he or she is performing a function of the Police in relation to the proceedings, and is not personally concerned with the facts of the proceedings, or closely connected with a party, witness, or prospective witness.

A jury panel is drawn from the people available to form a jury, and records the information about them that is used in court when chal-

lenges to jurors are made. Under the Jury Rules, that information must include the name, occupation, date of birth, and full address of a potential juror.

Concern was raised in 2010 when a self-represented defendant corresponded with people whose names and addresses were on the jury panel for his trial. The bill is intended to address this problem by amending the Juries Act 1981 to allow some information to be excluded from the jury panel. It would be called protected information, and access to it would be restricted.

Clauses 16(2) and 17 of the bill, as introduced, name "constables" as one group of persons eligible to inspect the jury panel list and the protected particulars. We consider that it would be inappropriate for any constable (or any other police employee) who was a party to proceedings, or in some way personally concerned with the proceedings, to view the jury panel or the protected particulars.
