Government Bill

Explanatory note

General policy statement

The Legal Services Bill will replace the current Legal Services Act 2000. The Bill will reform the legal aid system in the following ways:

- transferring the administration of publicly funded legal services to the Ministry of Justice and providing that the Secretary for Justice will be responsible for establishing and delivering different legal services; and
- disestablishing the Legal Services Agency and establishing a new statutory officer within the Ministry of Justice, the Legal Services Commissioner, who will be responsible for the granting of legal aid; and
- introducing a new quality assurance and performance management system for those providing publicly funded legal services under the Bill; and
- enabling the development of streamlined processes for assessing applications for certain low-cost criminal cases; and
- replacing the current Legal Aid Review Panel with a new Legal Aid Tribunal; and
- clarifying that legal aid is available for Waitangi Tribunal proceedings, but not negotiations with the Crown to achieve a settlement of a claim, as this process is funded by the Office of Treaty Settlements within the Ministry of Justice; and

making administrative improvements.

Background: Need for reform

Legal aid systems worldwide are facing serious challenges. In 2009, a fundamental review of the New Zealand legal aid system was commissioned to ensure New Zealand has an effective and sustainable legal aid system into the future. The review was chaired by Dame Margaret Bazley, who identified significant issues within the legal aid system. These included the variable quality of legal aid services and inadequate mechanisms to ensure quality, legislative impediments that contributed to market inefficiencies, and serious service delivery issues.

The Legal Services Bill will provide the basis for a new, more effective legal aid system that supports the wider justice sector. The proposals work as a package to create a system in which taxpayers can have confidence that legal aid expenditure is directed at high-quality legal services provided by competent lawyers. The new regime will focus on both quality and efficiency. The Bill reflects these objectives and allows for flexibility in the design and provision of services to ensure that the new system is administered in an effective and efficient manner by the Ministry of Justice.

Moving functions of Legal Services Agency into Ministry of Justice

The Bill disestablishes the Legal Services Agency and moves its functions into the Ministry of Justice. The Secretary for Justice will have the primary responsibility for the administration of the legal aid system. However, an independent statutory officer, the Legal Services Commissioner, will be established to ensure, in particular, that there is independence in the granting of legal aid to individuals. The Commissioner will also perform other tasks allocated by the Secretary for Justice.

Establishment and delivery of legal services

The Bill ensures that the Secretary for Justice will have the flexibility to establish different legal services and methods of delivering those services. For example, this will include assessing the specific needs for legal services by people with insufficient means within New

Zealand and developing the legal services that may be provided under the new regime. It will also include determining the method of delivery, such as employing salaried lawyers to provide services; entering into agreements with individual lawyers, firms, or groups of lawyers; and arranging for community law centres to deliver services.

New quality assurance framework

The Bill establishes a new quality framework for approving providers as follows:

- lawyers will need to meet new criteria, set by regulation, for approval as a provider of certain legal services, including legal aid services; and
- the Secretary for Justice will decide approvals based on the recommendation of Selection Committees, which will be established to assess and recommend whether lawyers should be approved to provide services; and
- lawyers will be approved to provide particular services for fixed periods; and
- lawyers will need to apply for re-approval once their period of approval expires; and
- the Ministry of Justice will monitor the performance of providers; and
- a Performance Review Committee will be established to consider concerns raised and recommend sanctions, where appropriate; and
- a Review Authority will be established to review decisions of the Secretary regarding approvals.

Streamlined eligibility process for certain applications

The Bill allows for the streamlining of legal aid granting processes for offences prescribed by regulation where grants are (or are likely to be) under a set amount. This will reduce the time lawyers and clients spend dealing with administrative matters. These grants will not be subject to a repayment obligation. However, where the set amount is exceeded (or the Commissioner considers it may be exceeded), the application will be determined under the standard granting processes.

This may include imposing repayment conditions based on the full amount of legal aid granted.

New Legal Aid Tribunal

The Legal Aid Review Panel will be replaced by a new Legal Aid Tribunal situated within the Ministry of Justice, which administers other tribunals.

Clarifying streams of funding for settlement negotiations

The Bill clarifies that legal aid is available for Waitangi Tribunal proceedings, but not negotiations with the Crown to achieve a settlement of a claim. This process is funded by the Office of Treaty Settlements within the Ministry of Justice.

Other administrative improvements

The Bill includes important administrative improvements. It provides for the ability to prescribe time frames for invoicing by legal aid providers. The Bill also improves the process for seeking information about a claim from the Waitangi Tribunal for the purposes of determining whether to grant an application for proceedings before the Tribunal

Regulatory impact statements

Clause by clause analysis

Clause 1 is the Title clause.

Clause 2 provides for the commencement. The Act comes into force on a date appointed by the Governor-General by Order in Council,

and 1 or more orders may be made appointing different dates for different provisions.

Commencement by Order in Council is necessary as the Bill brings about significant organisational change and time is required to ensure a smooth transition of the administration of the legal aid system to the Ministry of Justice, without disrupting service to people in need of legal aid. Once the Bill is enacted, time will be required to recruit and appoint the Legal Services Commissioner and members of the new legal aid Tribunal, as well as to draft and promulgate regulations under the new legislation.

Part 1 Preliminary provisions

Clause 3 states that the purpose of this Act is to promote access to justice by establishing a system that—

- provides legal services to people of insufficient means; and
- delivers those services in the most effective and efficient manner.

Clause 4 provides for the interpretation of terms used in the Act. Clause 4 contains several terms from the Legal Services Act 2000 (the **former Act**) and includes a number of new terms such as prescribed offence, practice standards, and specified legal services, as well as new definitions of former terms (for example, legal services, and community legal services).

Clause 4(5) is new in that references to things like fees, charges, disbursements, grants, and rates are references to those things exclusive of GST. Previously, these things were GST inclusive.

Clause 5 provides that this Act binds the Crown.

Part 2 Legal aid

Subpart 1—When legal aid may be granted

Subpart 1 establishes when legal aid may be granted by—

 specifying the types of criminal and civil proceedings for which legal aid may be granted (eligible proceedings) (*clauses* 6 and 7):

- specifying the criteria that the Commissioner must apply in determining when legal aid may be granted in relation to an eligible civil or criminal matter (*clauses 8, 10, and 11*):
- stating the situations in which legal aid must be refused or limited, or is not available (*clauses 12 and 13*).

Clause 9 relates to applications for legal aid in respect of criminal matters. If the application is for a prescribed offence, the Commissioner must, when determining whether the applicant has the means to pay for legal assistance, do so in the manner set out in regulations. (This means a different test for determining the applicant's means will apply for prescribed offences where the cost of legal aid is below a certain amount.)

Subpart 2—Application and grant

Clause 14 states how an application for legal aid must be made.

Clause 15 relates to applications of legal aid for a civil matter by minors and mentally disordered persons.

Clause 16 applies to the decision that must be made by the Commissioner on an application for legal aid. This clause has the same effect as its counterpart in the former Act except that the Commissioner may grant legal aid on an interim basis until the Commissioner decides the application or considers that payments made under that grant should cease. The provisions in *clause 32* relating to the consequences of withdrawing legal aid apply to any payments that have ceased under a grant of legal aid made on an interim basis.

Clause 17 is new. It requires the Commissioner to notify a person whose application is declined of his or her right to seek a reconsideration of the decision, and a review of a reconsideration of that decision

Clause 18 relates to the conditions on a grant of legal aid. This clause carries forward the relevant provision in the former Act with the following changes:

- the Commissioner may decide that a grant of legal aid made on an interim basis should not be subject to the condition that an aided person must make a repayment; and
- this clause does not apply to applications for legal aid by a person who is charged with or convicted of a prescribed offence and who is not otherwise disqualified by *clause 9(2)*.

Clauses 19 to 23 carry forward the provisions of the former Act about—

- conditions on grants to persons involved in proceedings under Domestic Violence Act 1995 (*clause 19*):
- the calculation of the amount of interim repayments payable under a grant of legal aid (*clause 20*):
- the determination of the amount of repayment payable under a grant of legal aid (*clause 21*):
- lead providers (*clause 22*):
- the maximum grant of legal aid that is authorised under the grant (*clause 23*).

Subpart 3—After legal aid is granted

Clauses 24 to 32 contain provisions that apply after legal aid is granted. The provisions of the former Act relating to the following matters are carried forward with little change:

- the requirement on the provider in civil proceedings to notify other parties (*clause 24*):
- the obligation of the aided person to notify the Commissioner of any change in his or her circumstances (*clause 25*):
- the duty of the Commissioner to keep the aided person informed (*clause 26*):
- the Commissioner's ability to fund legal services relating to private mediation (*clause 27*):
- the process for applications to amend a grant of legal aid (*clause 28*):
- the withdrawal of, or amendment to, a grant of legal aid in relation to a criminal matter (*clause 29*):
- the withdrawal of, or amendment to, a grant of legal aid in relation to a civil matter (*clause 30*):
- the withdrawal of a grant of legal aid by the Commissioner (*clause 31*):
- the consequences of withdrawing legal aid (*clause 32*).

Subpart 4—How Commissioner may enforce conditions of grant

This subpart carries forward the provisions of the former Act that relate to the following matters:

- the amount payable by aided person to the Commissioner (*clause 33*):
- that amounts payable under conditions of grant are debts due to the Commissioner (*clause 34*):
- the ability of the Commissioner to adjust the rate of payment of a legal aid debt (*clause 35*):
- that any proceeds of proceedings funded by legal aid are subject to a charge in favour of the Commissioner (*clause 36*):
- the ability of the Commissioner to exempt property from a charge (*clause 37*):
- the ability of the Commissioner to transfer a charge with the agreement of the aided person (*clause 38*):
- the enforcement of a charge by the Commissioner (*clause 39*):
- the power of the Commissioner to require an aided person to pay interest on unpaid legal aid debt (*clause 40*):
- the duty of the aided person to enforce a judgment or out-ofcourt settlement in order to recover the proceeds of proceedings (*clause 41*):
- the Commissioner's power to decide not to recover a legal aid debt in certain circumstances (*clause 42*):
- the power of the Commissioner to write off amounts payable in certain circumstances (*clause 43*):
- the duty of the Commissioner to refund excess payments (*clause 44*).

Subpart 5—Award of costs in civil proceedings

This subpart carries forward the provisions in the former Act that relate to—

• the court's determination of the liability of an aided person for costs in civil proceedings (*clause 45*):

• an application by a successful opponent of an aided person for costs in a civil proceeding (*clause 46*).

Subpart 6—Legal aid grants for Treaty of Waitangi claims

This subpart carries forward provisions of the former Act that relate to—

- applications for legal aid made in respect of proceedings before the Waitangi Tribunal (*clause 47*):
- the assessment of the financial resources of applicants involved in making a claim before the Waitangi Tribunal (*clause* 48):
- repayment conditions for legal aid granted for Waitangi Tribunal proceedings (*clause 50*).

Clause 49 continues to require the Waitangi Tribunal to provide information to the Commissioner in respect of applications for legal aid for proceedings before the Waitangi Tribunal. However, the information requirements will now be set out in regulations (instead of the Act), and the Commissioner may seek an up-to-date report of the information in certain circumstances.

Subpart 7—Reconsideration, review, and appeals of legal aid decisions

Clause 51 provides for the reconsideration of decisions of the Commissioner. The following changes are made:

- the time for applying for a reconsideration is within 20 working days after the date that the applicant receives notice of the relevant decision. However, the Commissioner may accept a late application (no later than 3 months after the date the applicant received notice of the decision) if certain criteria are met:
- a person may not seek a review of the Commissioner's decision unless the decision has been reconsidered (this does not apply where the person is seeking a review of a decision of the Commissioner on the payment of costs).

The functions of the Legal Aid Review Panel under the former Act will be now be performed by the Legal Aid Tribunal (the **Tribunal**).

Clause 52 sets out the grounds on which an aided person or an applicant for legal aid may apply to the Tribunal for a review of the Commissioner's reconsideration of a decision. This section repeats the grounds for review in the former Act except that the following decisions are no longer reviewable:

- a decision relating to the identity of a provider in a grant of legal aid:
- a decision relating to the amount payable to a provider under a grant of legal aid (see *clause 130* for transitional provisions for reviews on this ground).

Clauses 53 states how an application for review must be made to the Tribunal.

Clause 54 provides for the powers and duties of the chairperson on receipt of an application for review. The chairperson may assign 1 member of the Tribunal to conduct the review.

Clause 55 specifies how the Tribunal must conduct the review.

Clause 56 describes how the Tribunal may determine the review.

Clause 57 provides that the Tribunal may, instead of determining the review, direct the Commissioner to reconsider the decision to which the review relates.

Clause 58 empowers the chairperson to direct the publication of Tribunal decisions.

Appeals and references on question of law

Clauses 59 to 61 continue to—

- allow for appeals to the High Court on a question of law (*clause 59*):
- allow a decision of the High Court on a question of law to be appealed to the Court of Appeal and to the Supreme Court (*clause 60*):
- allow the chairperson of the Tribunal to state a case for the opinion of the High Court on a point of law arising out of a review (*clause 61*).

Subpart 8—Legal Aid Tribunal

This subpart—

• establishes the Tribunal (*clause 62*):

- states the functions of the Tribunal (*clause 63*):
- provides for the appointment of members of the Tribunal (*clause 64*):
- states the functions of the chairperson of the Tribunal (*clause* 65):
- enables the chairperson to delegate his or her functions, duties, and powers to a member of the Tribunal (*clause 66*).

Clause 64, which provides for appointment of members of the Tribunal, requires—

- that each member of the Tribunal must be a lawyer, and excludes the appointment of any person who is, or has been in the past 5 years, an employee of the Legal Services Agency, a member of the Board of the Agency, or an employee of the Ministry of Justice:
- that a person must not be appointed chairperson unless he or she has had 7 years' legal experience:
- that a person's approval to provide legal aid services (if any) ceases on being appointed chairperson.

Clause 67 states that Part 1 of Schedule 3 contains further provisions that apply to the Tribunal.

Part 3 Administration of legal Services system

Subpart 1—Functions of Secretary for Justice and Legal Services Commissioner

Clause 68 states the functions of the Secretary for Justice under this Act. A function of the Secretary is to establish, maintain, and fund high-quality legal services in accordance with this Act.

Clause 68(2) states the things that the Secretary may do for the purposes of performing his or her functions. For example, the Secretary may—

- assess and determine the need for legal services by people of insufficient means within New Zealand:
- determine the method or methods for the delivery of legal services:
- determine the allocation of legal services.

Clause 69 provides examples of methods for the delivery of legal services.

Legal Services Commissioner

Clause 70 provides for the appointment of the Legal Services Commissioner. The Commissioner must be an employee of the Ministry of Justice. Clause 70 also provides that the Commissioner must act under the direction of the Minister and the Secretary except when performing the functions that require him or her to act independently.

Clause 71 states the functions of the Commissioner. The following functions must be performed independently by the Commissioner:

- granting of legal aid:
- the determination of legal aid repayments:
- the assignment of a provider of legal aid services to an aided person:
- the management of salaried lawyers.

Clauses 72 and 73 relate to the delegation by the Commissioner of his or her powers, functions, or duties, and the powers of the delegate.

Subpart 2—Quality assurance system for providers

Providers of legal services

Clause 74 states that this subpart applies to providers of legal services or specified legal services, and every person who applies to provide any of those services.

Clause 75 prohibits a person from providing a legal aid service or specified legal service unless the person is approved to do so by the Secretary, and the person complies with the conditions (if any) of that approval.

Clause 76 states how to apply for approval to provide legal aid services or specified legal services.

Clause 77 relates to an approval by the Secretary to provide legal aid services or specified legal services. The Secretary may give his or her approval if satisfied that the person meets the prescribed criteria, and the Secretary may impose conditions on the approval.

Clause 78 allows the Secretary to establish 1 or more selection committees to assess applications for approval to provide legal aid ser-

vices or specified legal services and advise the Secretary of the suitability of those applicants.

A selection committee must be chaired by a representative from the Ministry of Justice and must include a lawyer from the New Zealand Law Society, and any other suitably qualified people that the Secretary thinks fit.

Clause 79 requires the Secretary to establish a performance review committee. The function of the committee is to investigate, and advise the Secretary of, any matter relating to the performance of a provider. (The Secretary may refer a matter to the committee if a provider has failed to comply with any condition of his or her approval, or any provision of this Act or the regulations, and the Secretary considers that the person's failure is serious enough to justify the review.)

Clause 80 states that Part 2 of Schedule 3 contains further provisions that apply to the performance review committee and selection committees

Clause 81 relates to the provider's obligations under rules or codes of conduct of any professional body to which the provider belongs.

Clause 82 allows a person who is affected by a decision of the Secretary (in relation to the person's approval to provide legal aid services or specified legal services) to apply to the Review Authority for a review of that decision.

Clause 83 prevents a person from seeking judicial review of the Secretary's decision under this subpart until the person has sought and obtained a review of the Secretary's decision under clause 82.

Review Authority

Clause 84 provides for the appointment of the Review Authority, who must be a lawyer with at least 7 years' legal experience.

Clause 85 provides that the function of the Review Authority is to review decisions of the Secretary—

- declining an application by a person to provide legal aid services or specified legal services:
- revoking or modifying a provider's approval:
- imposing any condition on a provider's approval.

Clause 86 states how the Review Authority may determine a review, and provides that the Review Authority's decision is binding on the Secretary and the person to whom the decision applies.

Clause 87 provides that Part 3 of Schedule 3 contains further provisions that apply to the Review Authority.

Quality assurance checks

Clause 88 enables the Ministry to carry out quality assurance checks on providers of legal aid services or specified legal services to ensure that the services are being provided in a manner consistent with the purpose of this Act.

Examination of claims made by providers

Clause 89 provides that the Commissioner may, in certain circumstances, examine a claim or part or a claim by a provider of legal aid services or specified legal services.

Clause 90 provides that an aided person may request an examination of the cost of services under a grant of legal aid.

Clause 91 enables the Secretary to audit a provider of legal aid or specified legal services. The audit must be conducted by an auditor. Clause 92 requires a provider who is subject to an examination or audit to co-operate with the auditor.

Subpart 3—Community law centres

Clause 93 provides a new definition of a community law centre, which is a body whose function includes the provision of community legal services. Community legal services means any legal services or law reform and advocacy work that a community law centre provides under a contract between the centre and the Secretary.

Clause 94 enables the Secretary to contract with a community law centre to purchase community legal services. The money for funding community law centres must come from the Special Fund or any other money.

Clause 95 requires the Secretary to provide a report to the Minister relating to the use of the Special Fund.

Clause 96 enables the Secretary to audit services offered by a community law centre under a contract for service. The audit must be conducted by an auditor.

Subpart 4—Payment for legal aid work, enforcement, and other matters relating to providers

Payment for legal aid work

Clause 97 states how a lead provider must claim for payment for legal aid services or specified legal services provided.

Clause 98 is new, and relates to the time frame for making claims for payment for legal aid or specified legal services.

Clause 99 provides that the Commissioner may approve, defer for examination, or decline the payment of a claim for payment for legal aid services. The fact that a claim was not made in accordance with clause 98 is a new ground for declining payment for legal aid services.

Clause 100 requires the Secretary to pay the lead provider in respect of every claim or part of a claim that is approved by the Commissioner for payment.

Enforcement

Clause 101 allows the Secretary to impose certain interim restrictions on a provider, pending an investigation by the performance review committee of a matter that relates to the provider's performance.

Clause 102 allows the Secretary to impose sanctions on a provider who has been subject to an investigation by the performance review committee. The Secretary may—

- modify or cancel the person's approval:
- require the person to be supervised:
- bar the person from applying for approval for a period between 3 months and 2 years.

Clause 103 is based on section 73 of the former Act, and sets out the circumstances in which the Secretary must cancel a provider's approval.

Further provisions relating to providers

Clause 104 requires that every provider must, when doing any thing required by or under this Act, do so in the prescribed manner.

Clauses 105 to 107 carry forward the provisions in the former Act that—

- prohibit providers from taking unauthorised payments from a person to whom legal aid services or specified legal services are provided (*clause 105*):
- require providers to pay legal aid disbursements (*clause 106*):
- require providers to protect the Commissioner's interests in relation to charges and proceeds of proceedings (*clause 107*).

Subpart 5—Miscellaneous provisions

Disclosure of information

Clause 108 carries forward provisions from the former Act about the disclosure of information.

Clause 109 is new. It provides that information disclosed under an audit under clause 92 or 96 does not subsequently affect any legal professional privilege to which the information may be subject, except for the purposes of—

- an audit:
- evidence in an investigation by the performance review committee.

Clause 110 enables the Commissioner to require up-to-date information about the person's financial means for the purposes of any decision under this Act.

Offences

Clauses 111 to 113 repeat the provisions of the former Act about—

- offences relating to misrepresentation, and failure to comply with information requirements under this Act or regulations (*clause 111*):
- offences in relation to false or misleading representations in applications for approval to provide legal aid services (*clause 112*):

• offences by a provider or former provider for failure to comply with audits (*clause 113*).

Regulations

Clause 114 enables the Governor-General to make, by Order in Council, regulations for stated purposes. Most of the regulation-making provisions are repeated from the former Act (paragraphs (a) to (m), (o), and (x) of subclause (1), and subclauses (2) to (8)). Paragraphs (n), and (p) to (w) of subclause (1) and subclauses (9) and (10) are new.

Service

Clause 115 states how a notice or communication required under this Act must be given or delivered.

Effect of rights conferred by this Act

Clause 116 states the effect of the rights or liabilities of an aided person under this Act.

Part 4 Transitional and saving provisions, amendments to other enactments, and repeals

Subpart 1—Transitional arrangements for transfer of Legal Services Agency to Ministry of Justice

Clause 117 disestablishes the Legal Services Agency.

Clause 118 disestablishes the Public Advisory Committee.

Clause 119 vests all assets, records, liabilities, and debts of the Legal Services Agency in the Ministry. However, this clause does not apply to charges.

Clauses 120 to 123 provide for the transfer of employees of the Legal Services Agency to the Ministry.

Matters to be transferred to Commissioner

Clause 124 vests in the Commissioner all charges created by or under the Legal Aid Act 1969, the Legal Services Act 1991, or the Legal Services Act 2000.

Clause 125 provides that every reference in an enactment (other than this Act), or in any instrument or register, to the Legal Services Board or the Legal Services Agency must, if the context requires, be construed as a reference to the Commissioner.

Subpart 2—Transition of matters commenced, approvals granted, and funding provided under former Act

Applications for review under former Act

Clauses 126 to 129 provide for the determination of applications to the Legal Aid Review Panel for review made immediately before the commencement of this Act. The Legal Aid Review Panel will continue to determine remaining applications for review until the close of the final transition day (the day that is 1 month after the date on which the Tribunal comes into force). Any applications that have not been determined by that time will be determined by the Tribunal.

Clause 130 allows a provider or former listed provider to apply to the Tribunal for a review under section 54(3) of the former Act of a decision relating to the amount payable by the Legal Services Agency to that provider in respect of any services provided before the commencement of this Act.

Clause 131 states how remaining applications for review and any application for review under section 54(3) of the former Act are to be determined.

Legal aid granted and repayments made under former Act

Clause 132 provides for the transition of legal aid granted under the former Act.

Legal aid for certain types of legal assistance in respect of Waitangi Tribunal proceedings under former Act

Clause 133 contains transitional provisions for applications for legal aid for certain types of legal assistance in respect of Waitangi Tribunal proceedings made before the commencement of this Act.

Community law centres

Clause 134 relates to funding provided to community law centres before the commencement of this Act.

Listed providers under former Act

Clause 135 enables a person who immediately before the commencement of this Act was a listed provider to be automatically approved as a provider of legal aid services for a period of 1 year from the commencement of this Act.

Subpart 3—Transition of matters commenced under Legal Services Act 1991

Legal aid granted and repayments made under Legal Services Act 1991

Clauses 136 and 137 provide for the transition of legal aid granted under the Legal Services Act 1991, and state how legal aid repayments under that Act are to be calculated in accordance with this Act.

Subpart 4—Amendments to other enactments

Lawyers and Conveyancers Act 2006

Clause 138 states that clauses 139 to 143 amend the Lawyers and Conveyancers Act 2006.

Clauses 139 to 143 provide for amendments to the Lawyers and Conveyancers Act 2006. The amendments require the Secretary of Justice to be informed of disciplinary matters under the Lawyers and Conveyancers Act 2006 that relate to a provider under this Act.

Consequential amendments to other enactments
Clause 144 provide that consequential amendments to other enactments are listed in Schedule 4.

 - (b) it appears to the Commissioner that the applicant does not have sufficient means to enable him or her to obtain legal assistance; and
 - (c) either— 10
 - (i) the offence to which the application relates is punishable by a maximum term of imprisonment of 6 months or more; or
 - (ii) it appears to the Commissioner that the interests of justice require that the applicant be granted 15 legal aid.
- (2) When considering whether the interests of justice require that the applicant be granted legal aid, the Commissioner—
 - (a) must have regard to—
 - (i) whether the applicant has any previous conviction; and
 - (ii) whether the applicant is charged with or convicted of an offence punishable by imprisonment;
 - (iii) whether there is a real likelihood that the applicant, if convicted, will be sentenced to imprisonment; and
 - (iv) whether the proceedings involve a substantial question of law; and
 - (v) whether there are complex factual, legal, or evidential matters that require the determination of a court; and

- (vi) whether the applicant is able to understand the proceedings or present his or her own case, whether orally or in writing; and
- (vii) in any proceeding to which **section 6(c)** applies, the consequences for the applicant if legal aid is not granted; and

(viii)	in respect of an appeal, the grounds of the appeal
	and

- (b) may have regard to any other circumstances that, in the opinion of the Commissioner, are relevant.
- (3) When determining whether an applicant has sufficient means 5 to enable him or her to obtain legal assistance, the Commissioner must, except as provided under **section 9(1)**, have regard to the applicant's income and disposable capital as set out in **Schedule 1**.
- (4) Subsection (1)(c)(i) does not apply in respect of—

- (a) an appeal; or
- (b) a proceeding to which **section 6(c)** applies.
- (5) Despite **subsection (1)(a)**, the Commissioner may not grant legal aid to a child or a young person (as those terms are defined in section 2(1) of the Children, Young Persons, and Their Families Act 1989) in respect of any proceedings against that child or young person for an offence, if those proceedings are heard in a Youth Court.

9 Prescribed offences

- (4) If an applicant applies for legal aid in connection with a matter in which numerous persons have the same interest, and the rules of court permit the applicant to sue or be sued on behalf of all those persons, then the Commissioner must refuse to grant legal aid if satisfied that—
 - (a) the refusal of legal aid to the applicant would not seriously prejudice the rights of the applicant; or
 - (b) it would be proper for the other persons having the same 30 interest to pay for the proceedings.
- (5) If an applicant has the right, according to the rules of court, to be joined with others as plaintiff in 1 action because a common question of law or fact arises, then the Commissioner may grant legal aid to the applicant that is limited to the proceedings necessary to preserve the applicant's right to relief.
