Commentary

Recommendation

The Government Administration Committee has examined the Passports Amendment Bill (No 2) and recommends that it be passed with the amendment shown.

Introduction

The Passports Amendment Bill (No 2) seeks to increase the convenience of passport services for travellers by extending the maximum validity period of adult passports from 5 to 10 years. The bill would also alter the maximum validity period of other types of travel documents. Other proposed changes aim to modernise the Passports Act 1992 to reflect advances in the security features of travel documents and other technological developments, particularly the increasingly electronic nature of passport services. The modernisation of New Zealand's passport legislation would bring us closer in line with our trading partners.

Validity period

There is broad public support for a 10-year maximum validity period for adult passports. Several submitters on the bill suggested that the maximum validity period should be extended to 10 years and nine months, because some countries will not allow travellers entry unless they hold a passport valid for a further six months. Ten years is at the upper end of what the International Civil Aviation Organisation considers advisable for security purposes. Furthermore, such an amendment could in the longer-term affect passport holders travelling to countries such as European Union member states which do not accept non-European Union passports issued for longer than 10 years.

Commencement date

There is a clear public desire that the maximum validity period for passports be extended sooner rather than later. Given the assurances we received that the Department of Internal Affairs is ready to implement the bill's proposed changes, we recommend amending clause 2 to bring the commencement date forward by one month. This would allow many adults who need to renew their passport for travel during the upcoming summer holiday period to benefit from a 10-year passport.

Fees for passport services

Submitters expressed apprehension about the bill's potential implications for passport application fees. The bill itself does not propose any set fees. Clause 34 merely seeks to update the principal Act's existing delegated powers to make fee-setting regulations. The clause would remove some redundant provisions, such as fees for inserting new pages into passport books (which is a service that is no longer offered); clarify the different types of services for which regulations requiring payment of fees could be made; and stipulate that fees may be set differentially depending on when, where, and how a passport application is made (such as overseas, in paper, or online). The clause does not change current practice, which is intended to be simply cost-recovery. Any rise in fees, or new fees, would remain a Government decision.

The Passports Amendment Bill (No 2) was referred to the committee on 18 June 2015. The closing date for submissions was 24 July 2015. We received and considered 20 submissions from interested groups and individuals. No submitters wished to be heard.
