An Act to amend The Disputes Tribunals Act 1988

#### BE IT ENACTED by the Parliament of New Zealand as follows:

#### **1** Short Title and commencement

- (1) This Act may be cited as the Disputes Tribunals Amendment Act 1998, and is part of The Disputes Tribunals Act 1988 ("the principal Act").
- (2) This Act comes into force on the day after the date on which it receives the Royal assent.
