#### The Parliament of New Zealand enacts as follows:

#### 1 Title

This Act is the Holidays Amendment Act (No 2) 2016.

#### 2 Commencement

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council, and 1 or more Orders in Council may be made bringing different provisions into force on different dates.
- (2) Any provision that has not earlier been brought into force comes into force on the day that is 2 years after the date on which this Act receives the Royal assent.

## Note

Changes authorised by subpart 2 of Part 2 of the Legislation Act 2012 have been made in this official reprint. Note 4 at the end of this reprint provides a list of the amendments incorporated.

This Act is administered by the Ministry of Business, Innovation, and Employment.

## 3 Principal Act

This Act amends the Holidays Act 2003 (the **principal Act**).

## 4 Section 68 amended (Proof of sickness or injury)

- (1) In section 68(3), replace "medical practitioner" with "health practitioner".
- (2) Replace section 68(5) with:
- (5) In this section, **health practitioner** has the same meaning as in section 5 of the Health Practitioners Competence Assurance Act 2003.
