An Act to amend the Maritime Transport Act 1994

#### BE IT ENACTED by the Parliament of New Zealand as follows:

#### 1 Short Title and commencement

- (1) This Act may be cited as the Maritime Transport Amendment Act 1999, and is part of the Maritime Transport Act 1994 (the principal Act).
- (2) Sections 11(1), 12, 13(2), and 20(1)(k) and (l), and (2) come into force on the commencement of Part 17 of the Maritime Transport Act 1994.
- (3) The rest of this Act comes into force on the day after the date on which it receives the Royal assent.

#### 2 Interpretation

Section 2(1) of the principal Act is amended by repealing the definition of the term **harbour**.

- "(b) Damages for loss of life or personal injuries suffered by any person on board another ship, that were caused wholly or partly by the fault of the defendant ship, unless proceedings are commenced within 2 years after the date when the damage or loss or injury was caused."
