An Act to remove The Radio Company Limited from the State-Owned Enterprises Act 1986 and other legislation

### BE IT ENACTED by the Parliament of New Zealand as follows:

- 1 Short Title and commencement
- (1) This Act may be cited as the Radio New Zealand Act (No 2) 1995.
- (2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council.
