## **An Act to amend the Transport (Vehicle and Driver Registration and Licensing) Act 1986**

**BE IT ENACTED by the Parliament of New Zealand as follows:**

### **1 Short Title and commencement**

- (1) This Act may be cited as the Transport (Vehicle and Driver Registration and Licensing) Amendment Act 1995, and shall be read together with and deemed part of the Transport (Vehicle and Driver Registration and Licensing) Act 1986 (hereinafter referred to as the “principal Act”).

- (2) Sections 2, 8, and 9 of this Act shall come into force on the day on which this Act receives the Royal assent.
- (3) Except as provided in subsection (2) of this section, this Act shall come into force on a date to be appointed by the Governor-General by Order in Council; and one or more Orders in Council may be made bringing different provisions into force on different dates.

#### **4 Applications for registration**

- (6) The Transport (Vehicle Registration and Licensing) Regulations 1994, Amendment No 1 (SR 1995/66) are hereby consequentially revoked.
