# An Act to confer further powers on the Wellington City Council

Note

#### 1 Short Title

This Act may be cited as the Wellington City Empowering and Amendment Act 1940.

# 2 Interpretation

In this Act, if not inconsistent with the context,— **Corporation** means the Corporation of the Mayor, Councillors, and Citizens of the City of Wellington.

# 3 Variation of trust of land held by Corporation in Waipapa Road to general municipal purposes

The purposes for which the land described in the Schedule is held by the Corporation—namely, the purposes of a public library and town hall site—are hereby cancelled, and it is hereby declared that the said Corporation shall in future hold the said land for general municipal purposes.

# 4 Alteration of position of access way to Nikau Street over Newtown Library site in the City of Wellington

Part 3 of the Schedule of the Wellington City Empowering Act 1930 is hereby repealed, and the following is substituted in lieu thereof:

#### "Part 3

"All that piece of land situate in the City of Wellington, containing 1 perch and sixty-seven hundredths of a perch (1.67 perches), be the same a little more or less, being part of Reserve 13, Town of Wellington, and being part of the land comprised in certificate of title, Volume 455, folio 169, Wellington Registry, as the same is more particularly delineated on a plan deposited in the office of the Chief Surveyor at Wellington as No 20615 and thereon coloured blue."

#### **Schedule**

All that piece of land situate in the City of Wellington, containing 1 rood 9 perches and four-tenths of a perch (1 rood 9.4 perches), being Lot 44, Block VI, on Deposited Plan No 1621, being part of Section 3, Evans Bay District, and being the residue of the land comprised in certificate of title, Volume 145, folio 256, Wellington Registry.

#### **Notes**

#### 1 General

This is a reprint of the Wellington City Empowering and Amendment Act 1940. The reprint incorporates all the amendments to the Act as at 31 August 1940, as specified in the list of amendments at the end of these notes.

Relevant provisions of any amending enactments that contain transitional, savings, or application provisions that cannot be compiled in the reprint are also included, after the principal enactment, in chronological order. For more information, *see* http://www.pco.parliament.govt.nz/reprints/.

#### 2 Status of reprints

Under section 16D of the Acts and Regulations Publication Act 1989, reprints are presumed to correctly state, as at the date of the reprint, the law enacted by the principal enactment and by the amendments to that enactment. This presumption applies even though editorial changes authorised by section 17C of the Acts and Regulations Publication Act 1989 have been made in the reprint.

This presumption may be rebutted by producing the official volumes of statutes or statutory regulations in which the principal enactment and its amendments are contained.

### 3 How reprints are prepared

A number of editorial conventions are followed in the preparation of reprints. For example, the enacting words are not included in Acts, and provisions that are repealed or revoked are omitted. # 4 Changes made under section 17C of the Acts and Regulations Publication Act 1989

Section 17C of the Acts and Regulations Publication Act 1989 authorises the making of editorial changes in a reprint as set out in sections 17D and 17E of that Act so that, to the extent permitted, the format and style of the reprinted enactment is consistent with current legislative drafting practice. Changes that would alter the effect of the legislation are not permitted. A new format of legislation was introduced on 1 January 2000. Changes to legislative drafting style have also been made since 1997, and are ongoing. To the extent permitted by section 17C of the Acts and Regulations Publication Act 1989, all legislation reprinted after 1 January 2000 is in the new format for legislation and reflects current drafting practice at the time of the reprint.

In outline, the editorial changes made in reprints under the authority of section 17C of the Acts and Regulations Publication Act 1989 are set out below, and they have been applied, where relevant, in the preparation of this reprint:

- omission of unnecessary referential words (such as "of this section" and "of this Act")
- typeface and type size (Times Roman, generally in 11.5 point)
- layout of provisions, including:
  - indentation
  - position of section headings (eg, the number and heading now appear above the section)
- format of definitions (eg, the defined term now appears in bold type, without quotation marks)
- format of dates (eg, a date formerly expressed as "the 1st day of January 1999" is now expressed as "1 January 1999")

- position of the date of assent (it now appears on the front page of each Act)
- punctuation (eg, colons are not used after definitions)
- Parts numbered with roman numerals are replaced with arabic numerals, and all cross-references are changed accordingly
- case and appearance of letters and words, including:
  - format of headings (eg, headings where each word formerly appeared with an initial capital letter followed by small capital letters are amended so that the heading appears in bold, with only the first word (and any proper nouns) appearing with an initial capital letter)
  - small capital letters in section and subsection references are now capital letters
- schedules are renumbered (eg, Schedule 1 replaces First Schedule), and all cross-references are changed accordingly
- running heads (the information that appears at the top of each page)
- format of two-column schedules of consequential amendments, and schedules of repeals (eg, they are rearranged into alphabetical order, rather than chronological).
