An Act to vest certain Lands in the District of Wyndham in Trustees, for the Recreation of the Inhabitants of Wyndham.

Preamble

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1 Short Title

The Short Title of this Act shall be The Wyndham Recreation Reserve Act 1877.

2 Lands vested in Trust

4 Trust may manage land

The Wyndham Town Board shall manage the said land as to it shall seem expedient, but so that the said land shall be used solely for recreation purposes for the inhabitants of the Township of Wyndham and surrounding district.

Section 4 was amended, as from 1 October 1915, by section 2 Wyndham Recreation Reserve Amendment Act 1915 (1915 No 6(L)) by substituting the words "Wyndham Town Board" for the words "Wyndham Recreation Reserve Trust".

5 May lease—Application of rents, etc

6 New Trustees how appointed

Section 6 was repealed, as from 1 October 1915, by section 6 Wyndham Recreation Reserve Amendment Act 1915 (1915 No 6(L)).

Schedule Reserve for recreation purposes, Wyndham.

All that parcel of land in the Provincial District of Otago, containing by admeasurement one hundred and fifty-three acres, more or less, situate in the Town of Wyndham, and being Section numbered sixtyone (61) on the map of the said town. Bounded by a line commencing at the south-eastern corner of Section numbered 5, Block I, Wyndham District, and proceeding due west, one hundred links; thence due south, two hundred and sixty links; thence in a south-westerly direction along road line, one thousand one hundred and forty links; thence in a west-north-westerly direction along the road line, three thousand four hundred and sixty links; thence due north to the road line on the bank of the Mataura River, two thousand one hundred and forty links; thence along that road in a north-easterly direction, three thousand nine hundred and forty links; thence along the Mimiahu River in a southerly direction, one thousand nine hundred and eight links; thence due south, one thousand one hundred and fifty links; thence due east to the town boundary, five hundred and fifty links; thence due south along that boundary, one thousand one hundred links, to the starting point: be all the aforesaid distances more or less.
