Regulations

1 Title

These regulations are the Civil Aviation (Offences) Amendment Regulations 2019.

2 Commencement

These regulations come into force on 1 February 2020.

3 Principal regulations

These regulations amend the Civil Aviation (Offences) Regulations 2006 (the **principal regulations**).

4 Schedule 1 amended

- (1) In Schedule 1, revoke the items relating to rules 115.215, 115.613(c), 115.667, 115.759(c), 121.223(a), 125.235, and 135.235.
- (2) In Schedule 1, replace the items relating to rules 43.63, 91.247(b), 91.247(c), 91.529(a), 91.529(f), 121.221(b), 125.233(b), and 135.233(b) with the corresponding items set out in Part 1 of the Schedule of these regulations.
- (3) In Schedule 1, insert in their appropriate numerical order the items set out in Part 2 of the Schedule of these regulations.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 February 2020, amend Schedule 1 of the Civil Aviation (Offences) Regulations 2006 (the **principal regulations**). The principal regulations prescribe breaches of the Civil Aviation Rules (the **rules**) that are offences and breaches that are infringement offences, and prescribe fines and infringement fees in respect of those offences.

The amendments update the list of offences in Schedule 1 to reflect amendments to the rules made in 2018.

Regulatory impact assessment

The Ministry of Transport produced regulatory impact assessments in May 2016 (Emergency Location of Aircraft), July 2017 (Small Issues Rule Amendments), August 2016 (ADS-B OUT Mandate above FL 245), and November 2017 (ICAO Alignment Project 2017) to help inform the decisions taken by the Government relating to the contents of this instrument.
