Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 12 January 2023, amend the Climate Change (Forestry) Regulations 2022 to change some of the fees and charges payable for matters relating to post-1989 forest land. Broadly, the changes are as follows:

- for an application to register as a participant for the activity of standard forestry, the fee plus hourly charge is changed to a flat fee (with the applicable fee depending on the area of the relevant post-1989 forest land):
- for the submission of various emissions returns, the fee plus hourly charge is changed to a flat fee:
- for travel for the purposes of checking that land is post-1989 forest land, the fee is increased:

- for an application to add 1 or more carbon accounting areas to post-1989 forest land for the activity of standard forestry, the fee plus hourly charge is changed to a flat fee (with the applicable fee depending on the area of the relevant post-1989 forest land):
- for a notice of transmission of interest, the fee plus hourly charge is changed to a flat fee:
- fees are introduced for—
 - an application or a notice that relates to ceasing participation in the activity of standard forestry for the whole or a part of 1 or more carbon accounting areas:
 - a request for participant-specific tables of carbon stock:
- the fee and hourly charge for an application to reconfigure carbon accounting areas is removed.
