#### Regulations

#### 1 Title

These regulations are the Climate Change (Synthetic Greenhouse Gas Levies) Amendment Regulations 2020.

#### 2 Commencement

These regulations come into force on 1 January 2021.

#### 3 Principal regulations

These regulations amend the Climate Change (Synthetic Greenhouse Gas Levies) Regulations 2013 (the **principal regulations**).

#### 4 Regulation 10 amended (Price of carbon)

In regulation 10, replace "2020 levy year is \$24.54" with "2021 levy year is \$25.60".

#### 5 Regulation 11 amended (Rates of levies prescribed)

In regulation 11(1) and (2), replace "2020" with "2021".

#### 6 Schedule 1 amended

In Schedule 1, seventh column, replace each amount set out in the first column of Schedule 1 of these regulations with the corresponding amount set out opposite to that amount in the second column of that schedule.

#### 7 Schedule 2 amended

- (1) In Schedule 2, items 1, 3, and 5, revoke the items that relate to air-conditioning machines containing HFC134A, single-phase, and of cooling capacity—
  - (a) less than or equal to 4 kW, and that specify the following Tariff items in the second column of that schedule:
    - (i) Tariff item 8415.10.10 03B:
    - (ii) Tariff item 8415.81.00 03G:
    - (iii) Tariff item 8415.82.10 03G; and
  - (b) greater than 4 kW and less than or equal to 7 kW, and that specify the following Tariff items in the second column of that schedule:
    - (i) Tariff item 8415.10.10 11C:
    - (ii) Tariff item 8415.81.00 11H:
    - (iii) Tariff item 8415.82.10 11H; and
  - (c) greater than 7 kW and less than or equal to 10 kW, and that specify the following Tariff items in the second column of that schedule:
    - (i) Tariff item 8415.10.10 23G:

- (ii) Tariff item 8415.81.00 24K:
- (iii) Tariff item 8415.82.10 24K; and
- (d) greater than 10 kW, and that specify the following Tariff items in the second column of that schedule:
  - (i) Tariff item 8415.10.10 28H:
  - (ii) Tariff item 8415.81.00 32L:
  - (iii) Tariff item 8415.82.10 32L.
- (2) In Schedule 2, item 1, item relating to air-conditioning machines containing R32, self-contained or split-system, three-phase (Tariff item 8415.10.10 40G), sixth column, replace "0" with "Actual amount".
- (3) In Schedule 2, item 4, item relating to air-conditioning machines containing R32, other than single- or three-phase (Tariff item 8415.81.00 42H), sixth column, replace "0" with "Actual amount".
- (4) In Schedule 2, item 7, revoke the item relating to parts (containing HFC134A) for air-conditioning machines comprising a motor-driven fan and elements for changing the temperature and humidity (Tariff item 8415.90.00 17F).
- (5) In Schedule 2, seventh column, as amended by subclauses (1) and (4), replace each amount set out in the first column of Schedule 2 of these regulations with the corresponding amount set out opposite to that amount in the second column of that schedule.

#### **Explanatory note**

This note is not part of the regulations, but is intended to indicate their general effect. These regulations, which come into force on 1 January 2021, amend the Climate Change (Synthetic Greenhouse Gas Levies) Regulations 2013. The amendments include—

- amending regulation 10 to specify the price of carbon for the 2021 levy year; and
- amending regulation 11 to specify 2021 as the levy year in which the amended rates of levies apply; and
- amending Schedules 1 and 2 to prescribe the levy rates for leviable motor vehicles and leviable goods; and
- amending Schedule 2 to revoke certain items relating to air-conditioning machines containing HFC134A.
