Regulations

1 Title

These regulations are the Climate Change (Synthetic Greenhouse Gas Levies) Amendment Regulations 2021.

2 Commencement

These regulations come into force on 1 January 2022.

3 Principal regulations

These regulations amend the Climate Change (Synthetic Greenhouse Gas Levies) Regulations 2013.

4 Regulation 10 amended (Price of carbon)

In regulation 10, replace "2021 levy year is \$25.60" with "2022 levy year is \$36.50".

5 Regulation 11 amended (Rates of levies prescribed)

In regulation 11(1) and (2), replace "2021" with "2022".

6 Schedule 1 amended

In Schedule 1, seventh column, replace each amount set out in the first column of Schedule 1 of these regulations with the corresponding amount set out opposite to that amount in the second column of that schedule.

7 Schedule 2 amended

- (1) In Schedule 2, item 1, Tariff item 8415.10.10 40G, first column, replace "three-phase" with "other than single- or three-phase".
- (2) In Schedule 2, item 4, Tariff item 8415.81.00 42H, first column, delete "three-phase,".

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect. These regulations, which come into force on 1 January 2022, amend the Climate Change (Synthetic Greenhouse Gas Levies) Regulations 2013. The amendments include—

- amending regulation 10 to specify the price of carbon for the 2022 levy year; and
- amending regulation 11 to specify 2022 as the levy year in which the amended rates of levies apply; and
- amending Schedules 1 and 2 to prescribe the levy rates for leviable motor vehicles and leviable goods; and
- amending Schedule 2 to correct minor errors and inconsistencies in the descriptions of items, units of measure, and the synthetic greenhouse gas content rates.

The 2022 levy year starts on 1 January 2022 and ends at the close of 31 December 2022.
