Regulations

1 Title

These regulations are the Climate Change (Forestry Sector) Amendment Regulations 2012.

2 Commencement

These regulations come into force on the 28th day after the date of their notification in the *Gazette*.

3 Principal regulations

These regulations amend the Climate Change (Forestry Sector) Regulations 2008 (the **principal regulations**).

4 Amendments to principal regulations

Amend the principal regulations as set out in the Schedule.

Schedule Amendments to principal regulations

Regulation 4

In regulation 4(1), definition of **participant-specific table**, replace "chief executive" with "EPA".

Regulation 8A

In regulation 8A(1), replace "chief executive" with "EPA" in each place.

In regulation 8A(2), replace "chief executive's" with "EPA's".

Regulation 14

In regulation 14(3)(a), after "section 179", insert "of the Act". In regulation 14(3)(b), after "section 181(3)", insert "of the Act".

Regulation 22A

In regulation 22A(1) and (2), replace "chief executive" with "EPA".

Regulation 22B

In regulation 22B, replace "chief executive" with "EPA" in each place.

Regulation 22C

In regulation 22C, replace "chief executive" with "EPA" in each place.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the 28th day after the date of their notification in the *Gazette*, amend the Climate Change (Forestry Sector) Regulations 2008 to replace references to the chief executive with references to the EPA. The provisions that these regulations amend were inserted in the principal regulations the day before the Environmental Protection Authority Act 2011 received the Royal assent and so could not be included in the amendments made by that Act.
