These rules are made under section 148 of the Senior Courts Act 2016, section 26 of the Court Martial Appeals Act 1953, section 386 of the Criminal Procedure Act 2011, section 73 of the Bail Act 2000, and section 228 of the District Court Act 2016—

- (a) on the advice and with the consent of the Executive Council; and
- (b) in the case of Parts 1 to 3 and 5 of these rules, with the concurrence of the Right Honourable the Chief Justice and at least 2 other members of the Rules Committee continued under section 155 of the Senior Courts Act 2016 (of whom at least 1 was a Judge of the High Court); and
- (c) in the case of Part 4 of these rules, with the concurrence of the Chief District Court Judge and at least 2 other members of the Rules Committee continued under section 155 of the Senior Courts Act 2016 (of whom at least 1 was a District Court Judge).
