Schedule 2 of the principal notice is amended by inserting, after the item relating to quota management area PAU 7—Challenger (Nelson/Marlborough), the following items:

"Quota management area SBW6A—Auckland Islands "All that area of New Zealand fisheries waters within Fishery Management Area 6 west of 168°30.0'E.

"Quota management area SBW6B—Bounty Platform

"All that area of New Zealand fisheries waters within Fishery Management Area 6 east of 176°E.

"Quota management area SBW6I—Campbell Rise

"All that area of New Zealand fisheries waters within Fishery Management Area 6 south of a line at 50°30.0'S, which line extends in the west to 168°30.0'E, and in the east to 176°E. This area is bounded in the west by a line extending due south from a point at 168°30.0'E, and in the east by a line extending due south from a point at 176°E. "Quota management area SBW6R—Pukaki Rise

"All that area of New Zealand fisheries waters within Fishery Management Area 6 north of a line at 50°30.0'S, which line extends in the west to 168°30.0'E, and in the east to 176°E. This area is bounded in the west by a line extending due north from a point at 168°30.0'E, and in the east by a line extending due north from a point at 176°E."
