These regulations, which come into force on 1 October 2007, amend the Fisheries (infringement Offences) Regulations 2001 by prescribing new infringement offences and infringement fees for the purposes of—

- the Fisheries (South-East Area Amateur Fishing) Regulations 1986:
- the Fisheries (Southland and Sub-Antarctic Areas Amateur Fishing) Regulations 1991:
- the Fisheries (Reporting) Regulations 2001.
