### **Notice**

#### **1 Title**

This notice is the Fisheries (Notification of Tāngata Kaitiaki/Tiaki for Area/Rohe Moana of Ngāti Kuta-Patukeha) Notice 2017.

#### **2 Commencement**

This notice comes into force on the day after the date of its notification in the *Gazette*.

#### **3 Customary food gathering area/rohe moana**

This notice applies to the customary food gathering area/rohe moana defined by clause 4 of the Fisheries (Kaimoana Customary Fishing) Notice (No. 4) 2012 (*Gazette* 2012, p 2737), which is an area from the Haumi River mouth to Taupiri Bay.

#### **4 Tangata whenua**

The tangata whenua of the area/rohe moana are the hapū specified in clause 5 of the Fisheries (Kaimoana Customary Fishing) Notice (No. 4) 2012 (*Gazette* 2012, p 2737).

## 5 Appointment cancelled

- (1) The Minister for Primary Industries has cancelled the appointment of Sonny George as a Tangata Kaitiaki/Tiaki for the area/rohe moana.
- (2) The cancellation took effect at the end of 16 February 2017.

## 6 New appointment

- (1) The Minister for Primary Industries has appointed Kara George as a Tangata Kaitiaki/Tiaki for the area/rohe moana.
- (2) The appointment took effect on 17 February 2017.

## Explanatory note

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice is made under the Fisheries (Kaimoana Customary Fishing) Regulations 1998 (the **regulations**). It comes into force on the day after the date of its notification in the *Gazette*.

The notice relates to a customary food gathering area/rohe moana of the tangata whenua represented by Ngāti Kuta-Patukeha. The area/rohe moana is an area from the Haumi River mouth to Taupiri Bay.

Notice is given of the cancellation of 1 Tangata Kaitiaki/Tiaki for the area/rohe moana and the appointment of a replacement Tangata Kaitiaki/Tiaki. The Minister for Primary Industries made the appointment at the request of the Waikare Maori Committee acting for Te Hapu o Te Kapotai.

The powers of Tāngata Kaitiaki/Tiaki are set out in the regulations.
