## 1 Title

This notice is the Fisheries (Notification of Tāngata Kaitiaki/Tiaki for Area/Rohe Moana of Ngāti Kuta-Patukeha) Notice (No 2) 2016.

## 2 Commencement

This notice comes into force on the day after the date of its notification in the *Gazette*.

## 3 Customary food gathering area/rohe moana

This notice applies to the customary food gathering area/rohe moana described in clause 4 of the Fisheries (Kaimoana Customary Fishing) Notice (No. 4) 2012 (*Gazette* 2012, p 2737), which is an area from the Haumi River mouth to Taupiri Bay.

#### 4 Tangata whenua of area/rohe moana

The hapū specified in clause 5 of the *Gazette* notice referred to in clause 3 are the tangata whenua of the area/rohe moana.

### 5 Appointments

- (1) The Minister for Primary Industries has appointed Titari Parkes and Alvin Rewha as Tāngata Kaitiaki/Tiaki for the area/rohe moana.
- (2) The appointments took effect on 26 July 2016.

## **Explanatory note**

This note is not part of the notice, but is intended to indicate its general effect.

This notice is made under the Fisheries (Kaimoana Customary Fishing) Regulations 1998 and comes into force on the day after the date of its notification in the *Gazette*.

This notice relates to a customary food gathering area/rohe moana of tangata whenua represented by Ngāti Kuta-Patukeha. The area/rohe moana is an area from the Haumi River mouth to Taupiri Bay.

Notice is given of the appointments of Titari Parkes and Alvin Rewha as additional Tāngata Kaitiaki/Tiaki with effect from 26 July 2016. The Minister for Primary Industries made the appointment at the request of Ngāti Kuta-Patukeha.

The Tāngata Kaitiaki/Tiaki for a customary food gathering area/rohe moana may authorise any individual to take fish, aquatic life, or seaweed for customary food gathering purposes from within the area/rohe moana.
