1 Title

These regulations are the Lawyers and Conveyancers Act (Legal Complaints Review Officer) Form and Fee Regulations 2008.

2 Commencement

These regulations come into force on 1 August 2008.

3 Form to be used for applications to Legal Complaints Review Officer

(1) An application to the Legal Complaints Review Officer for a review of a decision by a standards committee must be in a form approved by the chief executive of the Ministry of Justice after consultation with the Legal Complaints Review Officer.
