### **Order in Council**

### **Rate and amount of levy for each class of alcohol**

## Order

### 1 Title

This order is the Pae Ora (Healthy Futures) Alcohol Levy Order 2024.

### 2 Commencement

This order comes into force on 1 July 2024.

### 3 Interpretation

In this order, **Act** means the Pae Ora (Healthy Futures) Act 2022.

### 4 Amounts of levy set out in Schedule

The amount of levy payable under clause 5 of Schedule 6 of the Act for each class of alcohol for the financial year beginning on 1 July 2024 is set out in the third column of the Schedule.

### 5 Rates determined for classes of alcohol described as having variable rate

The rates used to determine the levy for the classes of alcohol described in the table in Schedule 7 of the Act as having a variable rate (classes B, E, and F) are set out in the second column of the Schedule.

### 6 Revocation

The Pae Ora (Healthy Futures) Alcohol Levy Order 2023 (SL 2023/69) is revoked.

### Explanatory note

*This note is not part of the order but is intended to indicate its general effect.*

This order, which comes into force on 1 July 2024,—

- fixes the amount of the levy payable for the financial year beginning on 1 July 2024 for each class of alcohol described in the Pae Ora (Healthy Futures) Act 2022 (the **Act**); and
- identifies the variable rate that the Act requires the Minister of Health to determine annually for each of the 3 classes of alcohol described in the table in Schedule 7 of the Act as having a variable rate (classes B, E, and F); and
- revokes the Pae Ora (Healthy Futures) Alcohol Levy Order 2023.
