1 Title

These regulations are the Residential Tenancies (Fees) Amendment Regulations 2024.

These regulations come into force on 1 July 2024.

3 Principal regulations

These regulations amend the Residential Tenancies (Fees) Regulations 1998.

4 **Regulation 2 amended (Tenancy Tribunal application fee)** In regulation 2(1), replace "\$20.44" with "\$27".

5 Regulation 4 amended (Records in Tribunal registry)

- (1) In regulation 4(1), replace "\$10.22" with "\$14".
- (2) In regulation 4(2), replace "51 cents" with "70 cents".

6 Regulation 5 amended (Fees for transcribing and copying of proceedings)

- (1) In regulation 5(1), replace "\$25.55" with "\$34".
- (2) In regulation 5(2), replace "\$10.22" with "\$14".

Explanatory note

This note is not part of the regulations but is intended to indicate their general effect.

These regulations, which come into force on 1 July 2024, amend the Residential Tenancies (Fees) Regulations 1998. These regulations increase the fees payable for—

- filing an application with the Tenancy Tribunal (the **Tribunal**):
- inspecting the records and papers relating to an application:
- transcribing or copying an audio tape of Tribunal proceedings.

The fees include goods and services tax. They are being adjusted to reflect increases in the New Zealand Consumers Price Index since they were last updated.
