## 1 Title and commencement

- (1) These regulations may be cited as the Traffic Amendment Regulations (No 4) 1999, and are part of the Traffic Regulations 1976¹ ("the principal regulations").
- (2) These regulations come into force on 25 October 1999.

# **Explanatory Note**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 25 October 1999, revoke regulations 73(1), 73(2), and 74 of the Traffic Regulations 1976. The revocations are a consequence of the making of the Land Transport Rule: Glazing, Windscreen Wipe and Wash, and Mirrors 1999, which comes into force on 25 October 1999.
