## 1958, No. 29

## An Act to amend the Auckland Harbour Bridge Act 1950 [23 September 1958]

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

- 1. Short Title—This Act may be cited as the Auckland Harbour Bridge Amendment Act 1958, and shall be read together with and deemed part of the Auckland Harbour Bridge Act 1950 (hereinafter referred to as the principal Act).
- 2. Tolls—(1) Section two of the principal Act is hereby amended by repealing the definition of the term "toll", and substituting the following definition:
  - "'Toll' means any reward or payment which the Authority is authorised to collect under this Act in respect of any traffic over the bridge authorised by this Act or by regulations or bylaws under this Act:".
- (2) Section forty-four of the principal Act is hereby amended by omitting the words "persons, vehicles, and animals", and substituting the word "vehicles".
- (3) Section forty-seven of the principal Act is hereby amended by omitting the words "animal or vehicle", and substituting the word "vehicle".

3. Bylaws—Section fifty-five of the principal Act is hereby amended as follows:

(a) By repealing paragraphs (c) and (d), and substituting

the following paragraphs:

"(c) Regulating the speed, times, and manner at or in which vehicles or any class of vehicles may be

driven on to, over, or off the bridge:

- "(d) Classifying traffic and regulating or prohibiting the use of the bridge by any class or classes of traffic or by persons or animals not conveyed in vehicles:":
  - (b) By adding to paragraph (h) the words "by vehicles according to the type or class of the vehicles":
  - (c) By omitting from paragraph (i) the word "using", and substituting the words "in respect of the use of".
  - 4. Bridge not road or street—Section thirty-six A of the principal Act, as inserted by section five of the Auckland Harbour Bridge Amendment Act 1956, is hereby amended by omitting from subsection two the words "a public highway", and substituting the words "a road or street".
  - 5. Penalties—(1) Section sixty-one of the principal Act is hereby amended by omitting the words "twenty pounds", and substituting the words "fifty pounds".

(2) Subsection two of section eighty-two of the principal Act is hereby amended by omitting the words "one hundred pounds", and substituting the words "fifty pounds".

6. Unauthorised expenditure—(1) Section seventy-four of the principal Act is hereby amended by repealing the proviso thereto, as added by section twenty-one of the Finance Act (No. 2) 1953, and substituting the following proviso:

"Provided that if the amount authorised by the foregoing provisions of this section is less than three hundred and fifty pounds for any year, the Authority may in that year expend as aforesaid a sum or sums not amounting in the whole to more than three hundred and fifty pounds."

(2) Section twenty-one of the Finance Act (No. 2) 1953

is hereby repealed.

(3) This section shall be deemed to have come into force on the first day of April, nineteen hundred and fifty-seven.
