Title.

An Acr to amend the Costley Training Institution Act, 1885.

[28th August, 1907.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

Short Title.

1. This Act may be cited as the Costley Training Institution Act Amendment Act, 1907, and shall be read together with and deemed to form part of the Costley Training Institution Act, 1885 (hereinafter referred to as the said Act).

Number of Trustees may be increased.

2. (1.) Notwithstanding anything in the said Act contained, the number of Trustees under the said Act may be increased to five by the appointment of two additional Trustees.

Additional Trustees appointed by Governor.

(2.) Such additional Trustees shall be appointed by the Governor, and the said Act shall be read and construed in all respects as if the number of Trustees originally appointed thereunder had been five instead of three.

Trustees incorporated.

3. The Trustees under the said Act shall be a body corporate (hereinafter referred to as the Board) under the name of the Costley Training Institution Trust Board, and by that name shall have perpetual succession and a common seal, and may hold and dispose of real and personal property of whatever kind, sue and be sued, and do and suffer all that bodies corporate may do and suffer.

Vesting of property.

4. All property, whether real or personal, held by the Trustees shall immediately upon the passing of this Act be deemed to be vested in the Board upon and subject to the same trusts, powers contracts, and equities as shall then affect the same.

5. Deeds may be made by the Board under its common seal, Execution of deeds. attested by the Trustees or any three of the Trustees for the time being constituting the Board, and all contracts may be made on behalf of the Board by the Trustees or by their authority in the same manner as if the Board were not a corporate body.

6. All powers vested in the Trustees by the said Act shall be Powers of Trustees vested in the Board, and all the powers of the Board or of the vested in Board. Trustees may be exercised by the Trustees or by a majority of them, or in such other manner as the Trustees or a majority of them shall from time to time determine.

7. All debts and liabilities incurred by the Trustees before the Liabilities of passing of this Act in the exercise of their powers under the said Trustees to be liabilities of Board. Act shall on the passing of this Act become the debts and liabilities of the Board.

8. All contracts made by the Trustees before the passing of this Contracts made by Act in the exercise of their powers under the said Act shall on the contracts of Board. passing of this Act be deemed to have been made by the Board.

9. All acts done by any person acting bona fide as a Trustee Acts of Trustees shall be valid notwithstanding any defect that may afterwards be validated. found in his appointment, and the signature of any person purporting to act as such Trustee shall be prima facie evidence of his being such Trustee.

10. Subject to the provisions of the said Act and of this Act, Rules. the Board may make rules for the conduct of its own business.

11. The acts of the Board or of the Trustees shall not be Acts of Board valid invalidated by the fact that the number of the Trustees is at any though number of Trustees time incomplete.

12. Section eleven of the said Act is hereby amended by section 11 of Act omitting the words "shall be audited in each year by such person of 1885 amended. as the Trustees shall appoint," and substituting therefor the words "shall be audited in each year by the Audit Office."

13. Section twelve of the said Act is hereby amended by Section 12 of Act omitting the word "Auditor," and substituting therefor the words of 1885 amended. "Audit Office."
