An Act to amend the Electricity Act 1945

[23 September 1958

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

- 1. Short Title—This Act may be cited as the Electricity Amendment Act 1958, and shall be read together with and deemed part of the Electricity Act 1945 (hereinafter referred to as the principal Act).
- 2. Change of title of Minister—Section two of the principal Act is hereby amended by repealing the definition of the term "Minister", and substituting the following definition: "Minister' means the Minister of Electricity."
- 3. Change of name of Department—Section three of the principal Act, as amended by section eleven of the Statutes Amendment Act 1949, is hereby further amended by repealing subsection one, and substituting the following subsection:

"(1) There shall be a Department of State to be called the New Zealand Electricity Department, which, under the control of the Minister, shall be charged with the administration of this Act, and of the Acts specified in the Schedule to this Act, and of all other enactments which are placed under its care or supervision or control, and with such other functions as may be lawfully conferred on it."

- 4. Consequential amendments—(1) Section fifty-two of the Auckland Electric Power Board Act 1921 is hereby amended by omitting from subsection two the words "Department of Public Works", and substituting the words "New Zealand Electricity Department".
- (2) Every reference to the Minister for the time being charged with the administration of the principal Act in the enactments specified in Part I of the Schedule to this Act or elsewhere in any Act, regulation, rule, bylaw, order, or other enactment, or in any contract, agreement, deed, instrument, application, licence, notice, or other document whatsoever shall, unless inconsistent with the context or with the foregoing provisions of this Act, be hereafter read as references to the Minister of Electricity, whether any such reference is made by virtue of the operation of section six of the principal Act or otherwise.
- (3) Every reference to the State Hydro-electric Department in the enactments specified in Part II of the Schedule to this Act or elsewhere in any Act, regulation, rule, bylaw, order, or other enactment, or in any contract, agreement, deed, instrument, application, licence, notice, or other document whatsoever shall, unless inconsistent with the context or with the foregoing provisions of this Act, be hereafter read as references to the New Zealand Electricity Department, whether any such reference is made by virtue of the operation of section six of the principal Act or otherwise.
