

# AN ACT to authorize the Corporation of the City of THLE. Auckland to consolidate certain Loans. [19th December, 1879.]

THEREAS under and by virtue of the provisions of Part XXI. of an Preamble. Act of the General Assembly of New Zealand, No. XXIV., made and passed in the thirty-first year of the reign of Her present Majesty, shortly intituled "The Municipal Corporations Act, 1867," the Council of the Borough of Auckland did, by resolution dated the twentythird day of October, one thousand eight hundred and seventy-one, borrow the sum of twenty thousand pounds, and caused the deben-
