Invercargill Gasworks Site. An Act to vest in the Mayor, Councillors, and Burgesses of the Borough of Invercargill, a certain Parcel of Land in the Borough of Invercargill, in Trust for the Purposes of a Site for Gasworks for the said Borough.

Preamble.

WHEREAS the Provincial Council of the late Province of Otago, on the twelfth day of May, one thousand eight hundred and seventy-four, resolved that a respectful address be presented to His Honor the Superintendent, requesting him to reserve as a site for gasworks in the Town of Invercargill all that piece or parcel of land forming part of the Esplanade on the western side of that town, being by admeasurement four acres, and which is comprised in the parcel of land described in the Schedule hereto: And whereas the said reserve was omitted to be made pursuant to the said resolution: And whereas by a grant from the Crown bearing date on or about the thirty-first day of March, one thousand eight hundred and seventy-five, all that parcel of land situated in the said Town of Invercargill, containing forty-three acres two roods and ten poles, more or less, and being Block Seventy-seven, was granted to the Superintendent of the Province of Otago and his successors, Superintendents of the said province, in trust as a recreation reserve for the inhabitants of the Town of Invercargill: And whereas the said land so granted as aforesaid comprises the parcel of land described in the said resolution, and also the parcel of land described in the said Schedule hereto: And whereas the Council of the Borough of Invercargill, acting upon the said resolution, have erected gasworks upon the said parcel of land: And whereas in order to give effect to the said resolution, and also for the sake of convenience to increase the area of the land to be used for such gasworks, it is expedient to vest in the Mayor, Councillors, and Burgesses of the Borough of Invercargill, as a site for such gasworks, the parcel of land described in the Schedule hereto:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

Short Title.

1. The Short Title of this Act is "The Invercargill Gasworks Site Act, 1881."

2. The parcel of land described in the Schedule hereto is hereby Land described in vested in the Mayor, Councillors, and Burgesses of the Borough of Schedule vested in Invercargill, and their successors, in trust for the purposes of a site lors, and Burgesses for gasworks, and for purposes incidental thereto.

All that piece or parcel of land being part of Block LXXVII., Town of Invercargill, containing 4 acres 1 rood 12 perches, commencing at a point on the western boundary of Railway Reserve 100.5 links due West of the south-west angle of the Drill-shed Reserve, and bounded by a line running due West, 550 links; thence due North, 850 links; thence due East, 468 links; thence along the western boundary of Railway Reserve at a bearing of 174° 30, a distance of 854 links, to the commencing point.
