AN ACT to alter the Purpose of a Reserve vested in the Christchurch City Council. Title.
[2nd October, 1902.]

WHEREAS the piece of land described in the First Schedule hereto is vested in the Christchurch City Council as a cemetery reserve, but is unsuitable for that purpose: And whereas it is expedient that the purpose of such reserve should be changed as hereinafter appears: Preamble

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is “The North Canterbury Common Hospital Reserve Act, 1902.” Short Title.

2. The land described in the First Schedule hereto shall, from the commencement of this Act, be vested in the Christchurch City Council as a site for a common hospital, to be erected under the provisions of section thirty-eight of “The Public Health Act, 1900,” for the benefit in common of the local authorities mentioned in the Second Schedule hereto. FIRST SCHEDULE.

ALL that parcel of land in the Canterbury Land District, containing by admeasurement 167 acres 1 rood 23 perches, more or less, being Sections Nos. 26467, 30347, 31788, 31789, and parts of Sections Nos. 32752 and 30339, Block VIII., Christchurch Survey District. Bounded towards the north-west by the road forming the north-western boundaries of Sections Nos. 31788 and 30347 from Bottle Lake Road to the north-eastern corner of Section No. 30347 aforesaid; thence towards the south-east by Sections Nos. 32752 and 763 to the westernmost corner of the last-mentioned section; thence towards the north-east, and again towards the north-west, by the said Section No. 763 to its easternmost corner; thence towards the east generally by a

right line to the westernmost corner of Section No. 30340, and thence by a right line to the easternmost corner of Section No. 31789; thence towards the south-east by the road forming the south-eastern boundaries of Sections Nos. 31789, 31788, and 26467, to Bottle Lake Road; and thence towards the west by the said Bottle Lake Road, which forms the western boundary of Section No. 26467 aforesaid, to the place of commencement: excepting from the above-described area the road which intersects Section No. 30347 aforesaid.
