An Act to Reserve Land as an Endowment for the Title. Harbour of Napier. 30th October, 1876.

E IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as

1. The Short Title of this Act shall be "The Napier Harbour Short Title. Board Act, 1876."

2. The lands described in the Schedule hereto are hereby reserved Lands described and set aside for the use benefit and endowment of the Harbour of in Schedule hereto vested in Napier Napier, in the Province of Hawke's Bay, and shall, from and after the Harbour Board. passing of this Act, vest in the Napier Harbour Board as constituted by "The Napier Harbour Act, 1875," and shall be held by the said Board upon the like trusts, with the powers and for the purposes in the said Act expressed.

3. It shall be lawful for the Governor, or any person whom he Governor may, on may appoint for that purpose, on behalf of Her Majesty, from time to sion of Pilot Reserve time and at any time hereafter, upon giving one month's notice in and Lighthouse and writing to the Board, to enter upon and take possession of the Pilot Signal Station Reserve. Reserve and Lighthouse and Signal Station Reserve included in the said Schedule.

Bounded to the North by Battery Road and Spencer Street; to the East by Spencer Street; to the South by Subsection No. 5, 360 links; and to the West by Hyderabad Road.

All that parcel of land situate in the Town of Napier, Province of Hawke's Bay, containing by admeasurement one acre, more or less, comprising Town Sections Nos. 463, 464, 465, and 470; bounded to the North by Hardinge Road, 400 links; to the East by Section No. 462, 250 links; to the South by Waghorn Street, 400 links; to the West by Section No. 469, 248 links.

All that parcel of land situate in the Town of Napier, Province of Hawke's Bay, containing by admeasurement thirty-six perches, more or less, being Town Section No. 471; bounded to the North by Hardinge Road, 100 links; to the East by Section No. 469, 245 links; to the South by Waghorn Street, 100 links; to the West by Section No. 472, 242½ links.
