An Act to change the Purposes for which certain Lands in the Title. Borough of New Plymouth are held by the Mayor, Councillors, [28th October, 1898. and Burgesses.

WHEREAS the Mayor, Councillors, and Burgesses of the Borough Preamble. of New Plymouth are desirous that the purposes for which certain lands in the said borough are vested in them should be changed:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:--

1. The Short Title of this Act is "The New Plymouth Borough Short Title. Reserves and Street Exchanges Act, 1898."

2. From and after the passing of this Act the parcels of land in Purposes for which the Borough of New Plymouth described in the First Column of the Schedule held Schedule hereto, now held by the Mayor, Councillors, and Burgesses changed. of the Borough of New Plymouth for the purposes specified opposite thereto respectively in the Second Column of the said Schedule, shall be held by the Mayor, Councillors, and Burgesses of the Borough of New Plymouth for the purposes specified opposite thereto respectively in the Third Column of the said Schedule.
