## 1891, No. 14.

AN Act to amend "The Post and Telegraph Classification and Title. Regulation Act, 1890." [29th August, 1891.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :-

1. The Short Title of this Act is "The Post and Telegraph short Title. Classification and Regulation Act Amendment Act, 1891."

2. Notwithstanding anything contained in the fourth section of Right to increments "The Post and Telegraph Classification and Regulation Act, 1890" to depend on good (hereinafter referred to as "the said Act"), the right to receive increment in any year shall depend upon the good and diligent conduct of the officer to whose salary such increment is attached, and a certificate thereof shall in each such case be given by the permanent head of the department; and if in the opinion of such permanent head the officer is not entitled to such increment he may issue an order depriving such officer of the increment for that year, which shall in that case not be paid.

But an appeal shall lie from the decision of the permanent head to the Postmaster-General, and his decision thereon shall be final.

3. The Governor in Council may from time to time, upon the Power to Governor recommendation of the Postmaster-General, fix the amount of salary in Council to fix to be paid to an officer at any sum within the maximum limits of without increment. the class or grade in which such officer is placed under the provisions of the said Act, and such amount shall be the salary payable to such officer or in respect of the office which he holds, without annual increment.

## 1891, No. 14.] Post and Telegraph Classification and [54 & 55 VICT. Regulation Act Amendment.

Amendments in First Schedule of "The Post and Telegraph Classification and Regulation Act, 1890." 4. The following amendments are made in the First Schedule to the said Act :---

The words and figures in the said Schedule-

Minimum. Maximum Office or Class. Increment. £ £ 160 180 (1st Grade Two annual increments of £10 each. Sixth Class 2nd Grade 115 150 Two annual increments of £10 each, and one of £15. are hereby repealed, and in lieu thereof the following words and figures are substituted :---

In the portion of the said First Schedule relating to the Nonclerical Division the following addition is made :---

Office or Class.	Minimum.	Maximum.	Increment.
Cadettes employed exclu- sively in the Telephone Exchange Branch	£ 40	£ 80	Four annual increments of £10 each, with lodging allowance of £20 for first year, £10 in the second year, and £5 in the third year when the cadette is stationed away from usual home.

Rights of officers transferred or promoted from Nonclerical Division.

Provision to extend to distributors on promotion or transfer.

Distributors and telegraph messageboys to reckon service in cases of superannuation or on services being dispensed with.

Additional regulations may be made. 5. In the event of the transfer or promotion of an officer being made from the Non-clerical Division to the Clerical Division, created by the said Act, such transferred or promoted officer if then receiving a higher salary than the minimum salary of the class to which he shall be so transferred or promoted shall continue to receive such first-mentioned salary until he shall be entitled to a further increment, or be further promoted or transferred, but subject to the provisions of the said Act and any regulations from time to time in force thereunder.

This provision shall extend to any distributor who may be promoted or transferred to the Clerical or Non-clerical Division.

6. In any case where a distributor or telegraph message-boy shall have been or be promoted or transferred to the Clerical or Non-clerical Division under the said Act, he shall in case of retirement upon superannuation allowance, or on his services being dispensed with through no fault of his own, be entitled to reckon the period he was employed as a distributor or telegraph messageboy, as the case may be.

7. The power conferred on the Governor in Council under the said Act to make, alter, and vary regulations from time to time shall include the following :---

- (1.) For fixing the minimum and maximum number of officers in each class or grade:
- (2.) Providing a minimum of salary in respect of which no deduc-

tions shall be made for the compensation fixed to be paid to officers on leaving the service :

- (3.) Charging rent for quarters belonging to Her Majesty and used or occupied by officers for domestic purposes, and to reduce or abolish any allowance for rent in lieu of quarters:
- (4.) For the temporary employment of any person in any branch of the service of the Post and Telegraph Department, and to provide that any person so employed possessing expert or technical knowledge or skill may be appointed permanently, but subject to his compliance with the regulations then in force :
- (5.) For the promotion or transfer of officers employed in one of the divisions of the department to the other of such divisions, as occasion may require; and also for the promotion or transfer of distributors and telegraph messageboys to the Clerical or Non-clerical Divisions of such department.
