Title. AN ACT in Supplement of “The Wellington College Reserves Confirmation Act, 1878.” [8th November, 1884.]

Preamble. WHEREAS the rural lands in the Township of Fitzherbert, in the Provincial District of Wellington, firstly and secondly described in the Schedule hereto, were withdrawn from sale by the Proclamation recited in “The Wellington College Reserves Confirmation Act, 1878” (herein referred to as “the said Act”), to be conveyed as reserves to the Governors of the Wellington College, but were omitted from the Schedule of the said Act: And whereas the suburban lands in the Borough of Palmerston North, in the same provincial district, thirdly described in the Schedule hereto, were originally intended to be withdrawn from sale and set apart as reserves for the purpose aforesaid, and the said lands have remained up to the present time withdrawn from sale, but have not been legally reserved: And whereas it is expedient to authorize the issue of grants to be made of the said lands, in manner herein mentioned:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

Short Title. 1. The Short Title of this Act is “The Wellington College Reserves Confirmation Act, 1884.”

Reserves vested in Wellington College. 2. The lands specified in the Schedule hereto are hereby vested in the Governors of the Wellington College, in trust for the purposes of the said College, as provided in “The Wellington College Act, 1872,” and in any Act amending the same.

SCHEDULE.

ALL that parcel of land containing by admeasurement 451 acres and 2 perches, more or less, being the Rural Sections Nos. 113, 114, and 115 on the plan of the Township of Fitzherbert, in the Manawatu District. Bounded towards the North-east and East by a public road, 2734 links, 756 links, 285 links, 435 links, 320 links, 447 links, 338 links, 298 links, 329 links, 179 links, and 500 links; towards the South-east by unsurveyed land, 7140 links; towards the South-west by Sections Nos. 117, 118, and

119, 5625 links; and towards the North-west by Section No. 116, 7484 links. Also all that other parcel of land containing by admeasurement 92 acres 3 roods 15 perches, more or less, being the Rural Section No. 99 on the said plan. Bounded towards the North-east and South-east by Sections Nos. 98 and 120, 2572 links and 3610 links respectively; towards the South-west by a public road, 2572 links; and towards the North-west by Section No. 100, 3610 links.

All that parcel of land containing by admeasurement 305 acres, more or less, being the Rural Sections Nos. 109, 110, and 111 on the plan of the Township of Fitzherbert, in the Manawatu District. Bounded towards the North-east by the Kahuterawa Stream; towards the South-east by unsurveyed land, 6800 links; towards the West and South-west by a public road, 494 links, 156 links, 282 links, 346 links, 328 links, 383 links, 317 links, 452 links, 328 links, 817 links, and 2657 links; and towards the North-west by Section No. 112, 5900 links.

All that parcel of land containing by admeasurement 32 acres 2 roods 36 perches, more or less, being the Suburban Sections Nos. 1019, 1021, 1023, 1025, 1027, 1029, and 1031 on the plan of the Borough of Palmerston, in the Manawatu District. Bounded towards the North-east by a public road, 850 links; towards the South-east by Sections Nos. 1020, 1022, 1024, 1026, 1028, 1030, and 1032, 3850 links; towards the South-west by a public road, 850 links; and towards the North-west by a public road, 3850 links.
