An Act to amend the War Pensions and Allowances Title. (Mercantile Marine) Act, 1940.

[11th November, 1947

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:-

1. (1) This Act may be cited as the War Pensions Short Title and Allowances (Mercantile Marine) Amendment Act, and commencement. 1947, and shall be read together with and deemed part of the War Pensions and Allowances (Mercantile 1940, No. 24 Marine) Act, 1940 (hereinafter referred to as the principal Act).

- (2) This Act shall be deemed to have come into force on the first day of October, nineteen hundred and forty-seven.
- 2. (1) The principal Act (as amended by subsection Maximum one of section two of the War Pensions and Allowances rates of pensions in (Mercantile Marine) Amendment Act, 1946) is hereby case of further amended by repealing the First Schedule, and death. substituting the First Schedule set out in the Schedule 1946, No. 18 to this Act.

(2) The First Schedule to the War Pensions and Repeal. Allowances (Mercantile Marine) Amendment Act, 1946, is hereby repealed.
