A BILL INTITULED :

**An Act to apply certain sums out of the Ordinary Revenue and other monies to the service of the year ending the thirtieth day of June one thousand eight hundred and sixty-three.** Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows :

I. The Short Title of this Act shall be "The Appropriation Act 1862-3." Short Title.

II. Out of the Ordinary Revenue of the Colony for the year ended the 30th day of June 1862 there shall and may be issued and applied towards making good the Supply granted to Her Majesty in addition to the sum mentioned in the "Civil List Act" and other Acts for the Service of the said year ended the 30th day of June 1862 the sum of Twelve thousand four hundred and eighty-two pounds Nineteen shillings and Six pence. Supplementary Appropriation for past service £12,482 19s. 6d.

III. Out of the Ordinary Revenue of the Colony for the year ending the 30th day of June 1863 there shall and may be issued and applied towards making good the supply granted to Her Majesty for the service of the year ending the 30th day of June 1863 in addition to the sums mentioned in the "Civil List Act" and other General Appropriation for current year £184,056 4s.

XXI. There shall and may be issued and applied out of the sum of one hundred and eighty thousand pounds authorised to be raised by the "New Zealand Loan Act 1856" for the purposes of extinguishing the Native Title to Land in the Provinces of Auckland Wellington and Taranaki the unexpended balances of the respective sums allocated to each of the said Provinces by the "Public Debt Apportionment Act 1858."

Provision for Land Purchase

XXII. In order to provide means in advance of the receipts of the Ordinary Revenue for defraying the authorised expenditure of the General Government it shall be lawful for the Colonial Treasurer if thereunto authorised by an Order of the Governor in Council from time to time to borrow and take up money on the security of Treasury Bills carrying interest at a rate not exceeding six pounds per centum per annum and payable out of the Ordinary Revenue at the expiration of a time not exceeding twelve calendar months from the date thereof Provided that the total amount of principal money owing on the security of such Treasury Bills for the time being in circulation under this Act shall not in the aggregate at any time exceed thirty-five thousand pounds.

XXIII. Until permanent arrangement shall be made for the expenditure incurred on account of the Native Insurrection and in order to make temporary provision for purposes of defence and the construction of roads in the mixed and Native Districts of the Northern Island of New Zealand it shall be lawful for the Colonial Treasurer if thereunto authorised by an Order of the Governor in Council from time to time to borrow and to take up at interest at a rate not exceeding six pounds per centum per annum payable out of the Ordinary Revenue any further sums of money not exceeding in the whole one hundred and fifty thousand pounds on the security of Treasury Bills payable at the expiration of a term not exceeding twelve months from the date thereof.

XXIV. If in the opinion of His Excellency the Governor the interests of the Public Service do not require the next Session of the General Assembly to be held before the thirtieth day of June 1863 and if such Session be not held before that date there shall and may be issued and applied out of the Ordinary Revenue

XXV. The Treasurer of New Zealand shall issue and pay the said several sums hereby Appropriated to such persons for the purposes herein-before mentioned upon such days and in such proportions as the Governor by any Warrant to be signed by him shall from time to time order and direct and the payment so to be made shall be charged upon and payable out of such Revenues as aforesaid.

XXVI. The said Treasurer shall in his accounts from time to time be allowed credit for any sum of money paid by him in pursuance of any Warrant issued by virtue of this Act and the receipt of the person to whom the same shall be so paid shall be a full and valid discharge to the said Treasurer in passing his said accounts or any such sum as shall be therein mentioned.
