A BILL INTITLED

AN ACT to appropriate and apply certain Sums of Money out of the Consolidated Fund, the Public Works Fund, and other Accounts to the Services of the Year ending the Thirty-first Day of March, One thousand nine hundred and five, and to appropriate the Supplies granted in this Present Session.

MOST GRACIOUS SOVEREIGN,—We, Your Majesty's most dutiful and loyal subjects, the House of Representatives of New Zealand, in Parliament assembled, towards making good the supply which we have cheerfully granted to Your Majesty in this session of Parliament, have resolved to grant unto Your Majesty the sums hereinafter mentioned, and do therefore most humbly beseech Your Majesty that it may be enacted: And be it enacted by the General Assembly of New Zealand in this present Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Appropriation Act, 1904."

2. The Colonial Treasurer may issue and apply out of the Consolidated Fund, towards making good the supplies granted to His Majesty for the services of the year ending on the thirty-first day of March, one thousand nine hundred and five, any sums not exceeding in the whole the sum of one million four hundred and four thousand eight hundred and six pounds, together with the amount of the fees hereinafter mentioned.

3. All sums granted as aforesaid out of the Consolidated Fund by this Act, together with the sums granted out of that fund by the other Acts mentioned in First Schedule hereto, amounting in

the whole to four million seventy thousand and twenty-five pounds, as appears by the said Schedule, together with the fees collected by such public officers as are authorised to retain the same in lieu of salary, are hereby appropriated for the several services and purposes expressed in the several votes specified in the Abstract in the said First Schedule. 5

4. The Colonial Treasurer may issue and apply out of the Public Works Fund, towards making good the supplies granted to His Majesty for the works and services of the year ending as aforesaid, any sums not exceeding in the whole the sum of four hundred and thirty-five thousand eight hundred and fifty-seven pounds. 10

5. All sums granted as aforesaid out of the Public Works Fund by this Act, together with the sums granted out of that fund by the other Acts mentioned in the Second Schedule hereto, amounting in the whole one million four hundred and sixty-one thousand one hundred and ninety pounds, as appears by the said Second Schedule, are hereby appropriated for the several works and services expressed in the several votes specified in the Abstract in the said Second Schedule. 15

6. Out of the respective accounts mentioned in the Abstract in the Third Schedule hereto the Colonial Treasurer may issue and apply, towards making good the supplies granted to His Majesty for the services of the year ending as aforesaid, any sums not exceeding in the whole the sum of one hundred and sixty-one thousand five hundred and twenty pounds. 20

7. All sums granted as aforesaid out of the said respective accounts by this Act, together with the sums granted out of those accounts by the other Acts mentioned in the said Third Schedule hereto, amounting in the whole to four hundred and sixty-six thousand three hundred and forty-nine pounds, as appears by the said Schedule, are hereby appropriated for the respective services and purposes expressed in the several votes specified in the Abstract in the said Third Schedule. 30

8. Whereas the Colonial Treasurer has, under the authority of section forty-eight of "The Public Revenues Act, 1891," issued, during the twelve months ended the thirty-first day of March, one thousand nine hundred and four, in excess of or without the appropriation of Parliament, the respective sums mentioned in the Fifth Schedule hereto, out of the Consolidated Fund, the Public Works Fund, and the other accounts mentioned in the said Schedule, amounting in the whole to the sum of sixty-two thousand nine hundred and fifty-two pounds eighteen shillings and ninepence, and has also discharged from the Public Account the sum of fourteen pounds fourteen shillings, mentioned in the said Schedule as being due to but irrecoverable by the Crown, and has caused the said sums to be applied to the several purposes and services mentioned in the said Fifth Schedule: Be it enacted that the application and discharge of the said sums are hereby sanctioned. 45

Subsidies to be paid  
to local bodies.

9. (1.) There shall be issued and paid by the Colonial Treasurer out of the Consolidated Fund to the Council or Board of each county, road district, and town district, in respect of the general rates described in the Schedule to "The Local Bodies' Finance and Powers Act, 1885" (in this section referred to as "the said Act"), levied for the year ending as aforesaid, and actually collected 55

on or before the thirtieth day of June ensuing next after the said thirty-first day of March, one-fourth of the amounts to which they would be entitled under the plan of distribution described in the Schedule to the said Act.

5 (2.) Upon the application of the local body, setting forth the amount of general rates collectible for the year ending the said thirty-first day of March, and showing separately how much thereof is in respect of Native lands, seventy-five per centum, and no more, of the amount which it is estimated by the Valuer-General 10 may become payable to such local body for rates other than rates on Native lands may be advanced to such local body within that year.

(3.) On receipt by the Valuer-General of returns, duly verified by the declaration of the Chairman or Treasurer of a local body, 15 showing the amount of the rates aforesaid actually collected to the said thirtieth day of June, the amount of subsidy found to be payable in respect of such rates, less the amount (if any) advanced as aforesaid, shall be paid to such local body; and any sum advanced in excess of the amount so found to be payable 20 shall be repaid by the local body to the Public Account, or be recovered by the Colonial Treasurer out of any moneys payable to such local body.

(4.) Where a local body has adopted "The Rating on Un-improved Value Act, 1896," no subsidy shall be payable on any 25 amount exceeding the sum which would be recoverable on a rate of three farthings in the pound on the capital or gross value of the rateable property in its district.

(5.) The provisions of the first paragraph of the Schedule to the said Act, and of the last preceding subsection hereof, shall 30 apply to subsidies payable to Borough Councils under "The Municipal Corporations Act, 1900."

(6.) In case any doubt arises as to the several payments to be made under this section, or as to payments to be made in respect of newly formed districts wherein the local body has not 35 had sufficient time to levy and collect rates, the Governor in Council may decide the amounts of such payments, and his decision shall be final.

10. (1.) The Colonial Treasurer is hereby authorised to issue and pay out of the Consolidated Fund, by way of temporary 40 advance, any sum or sums, not exceeding in the whole the sum of one thousand pounds; for the purpose of defraying any charges or expenses incurred by or on behalf of any local governing body.

Authority to make temporary advances to local governing bodies.

(2.) All such advances shall be repaid to the Consolidated Fund 45 out of the first moneys thereafter accruing to such local governing body, and may be deducted or recovered by the Colonial Treasurer accordingly.

(3.) For the purposes of this section the expression "local governing body" means a County Council, Borough Council, Town 50 Board, Road Board, River Board, Harbour Board, and an Education Board, and includes any other body or persons, however designated, to whom any moneys are payable out of the Consolidated Fund.

11. (1.) Whenever it becomes necessary that money should be expended on account of the Government Insurance Department, the Public Trust Office, or the Government Advances to Settlers Office, in excess of or without the appropriation of Parliament, the Government Insurance Commissioner, the Public Trustee, or the Superintendent, as the case may be, may, with the sanction of the Colonial Treasurer, but not otherwise, pay such money in excess of or without the appropriation of Parliament. 5

(2.) All such expenditure shall be charged to the Unauthorised Expenditure Account. 10

Purchase of silver  
and bronze coin.

12. The Colonial Treasurer is hereby authorised to arrange with any or all of the banking institutions doing business in this colony for the purchase on their behalf (including the expenses incidental thereto), without further appropriation than this Act, of silver and bronze coin from the Royal Mint in London, or from any branch thereof in Australia, to an amount not exceeding one hundred thousand pounds. 15

13. The Colonial Treasurer may transfer any sum or sums not exceeding in the whole six hundred and fifty thousand pounds from the Consolidated Fund to the Public Works Fund, to be issued and applied to the purposes and services provided for in this Act. 20

Power to make  
contracts in excess  
of appropriation.

14. It shall be lawful for the Governor, in the name and on behalf of His Majesty the King, to enter into any contracts, or to incur any liabilities, for carrying on the works and services for which money is appropriated by this Act: Provided that in the case of the works and services specified in the Fourth Schedule hereto the amount of liability thereby incurred shall not, together with the sum appropriated therefor, exceed the sum set down in the ninth column in that Schedule opposite to each such work or service. 25

Power to pay over

15. Out of the moneys appropriated by this Act for the construction of public roads, and such other public works as are usually constructed by or are under the control of local governing bodies, sums may be paid over to such local governing body or bodies as the Minister in charge of the department in connection with which such roads or works are constructed determines, to such amounts and upon such terms and conditions as such Minister prescribes, to be expended by such body upon any of the works or services for which the same are appropriated by this Act; and the Colonial Treasurer shall make all such payments accordingly. 30 35

Money appropriated  
for roads, &c.,  
defined.

16. (1.) The moneys appropriated by this Act for the construction or improvement of railways, roads, bridges, buildings, and other public works shall be available for all or any of the following purposes:— 40

- (a.) The construction of railways, and the construction and repair of roads, drains, buildings, bridges, jetties, and wharves; 45
- (b.) The protection of and improvement of the navigation of rivers and lakes;
- (c.) The acquisition of land;
- (d.) The payment of salaries, allowances, and travelling-expenses, and the wages of workers; 50
- (e.) The purchase of material and provisions;
- (f.) The purchase of furniture and fittings for public buildings, and the payment of wages and purchase of furniture, provisions, and other necessaries for the maintenance of sanatoria and other establishments for which money is 55 appropriated;

- (g.) The purchase of tools, plant, provisions, clothing, and other requisites connected with the employment of labour, and whether or not the same are to be used for the benefit of or sold or lent to workers employed on public works ;
- 5 (h.) The payment of fares and freights by land or sea in respect of the transit of such workers, their families and effects, to or from their work ;
- (i.) The cost of any material or stores required for the effectual carrying-out of any of the aforesaid works or purposes ;
- 10 and
- (j.) The payment of compensation and costs payable under "The Workers' Compensation for Accidents Act, 1900," in respect of injuries to workers employed on any of the aforesaid works.

15 (2.) The cost of tools, plant, provisions, clothing, or other requisites sold or lent to workers as aforesaid may be deducted from time to time in one or more sums of money from the money earned, whether by day-labour or by co-operative contract, by the person to whom the same are sold or lent.

20 17. The Colonial Treasurer may issue and pay out of the Consolidated Fund all moneys lawfully payable to any Natives under and by virtue of the agreements validated by "The Auckland Goldfields Proclamations Validation Act, 1869," or to any persons lawfully entitled to the lands from which the revenues accrue in virtue

25 of any such agreement.

Authority to pay moneys under agreements validated by "The Auckland Goldfields Proclamations Validation Act, 1869."

18. Whereas under "The Lands Improvement and Native Lands Acquisition Act, 1894," the Colonial Treasurer is authorised to make advances to settlers for improving their lands : Be it enacted that all such advances and the expenses connected therewith, whether such

30 advances are made directly to any member of an association or expended by or under the directions of the Minister of Lands, may be paid out of the vote taken in Class XXXVII., Public Works Fund, for improved-farm settlements.

Advances under "The Lands Improvement and Native Lands Acquisition Act, 1894," authorised.

19. From and after the passing of this Act the cost of collection referred to in section three of "The Local Bodies' Finance and Powers Act, 1885," shall not be defrayed out of the revenues which by virtue of that section form part of the County Fund, and that Act is hereby amended accordingly.

20. In any case where the Colonial Treasurer is satisfied that any local authority liable to make any payment in respect of the costs and expenses incident to the election and meetings of the Licensing Committee, as provided in section sixteen of "The Alcoholic Liquors Sale Control Act Amendment Act, 1895," has made default in so doing, he may pay the same, and may cause the

40 amount so paid to be recovered from the defaulting local authority as a debt due to the Crown, or to be deducted from any subsidy or other moneys at any time payable by the Government to such local authority.

Costs of elections of Licensing Committees may be recovered.

21. The Colonial Treasurer is hereby empowered to make

50 arrangements with the Imperial Government or other authority, civil or military, on behalf of the colony, for the payment of all or any of the expenses incidental to or arising out of the equipping and maintaining the contingents of mounted infantry raised for service in South Africa, including the costs of embarkation and transport to

55 and from South Africa.

Authority to arrange with Imperial Government.

Public Trustee may purchase new premises.

22. The Public Trustee, with the sanction of the Trust Office Board, may, notwithstanding anything contained in section thirty-seven of "The Public Trust Office Consolidation Act, 1894," or any Act, out of any balance to the credit of the Profit and Loss Account, apply any sum not exceeding fifteen thousand pounds in the purchase of land with buildings thereon, and in any alterations thereto, or in the purchase of land and the erection of buildings thereon, in the City of Wellington, and in providing office accommodation and furniture for the purpose of carrying on the business of the Public Trust Office. 5 10

Payment of £100 to Sir W. J. Steward authorised.

23. The sum of one hundred pounds to be paid out of Vote No. 3, in Class I., Legislative Departments, to Sir W. J. Steward for the copyright and compilation of Parliamentary Procedure shall not be deemed to be a payment to a contractor within the meaning of section fifteen of "The Electoral Act, 1902." 15

Point Elizabeth Railway to be treated as part of the Government railways.

24. Whereas out of the State Coal-mines Account various sums, amounting in the whole to fifty-eight thousand eight hundred and seventy-eight pounds, have been expended in acquiring and partially completing the Point Elizabeth Railway, and it is expedient that the said railway should be treated as part of the Government railways: Be it therefore enacted as follows:— 20

- (a.) The said sum of fifty-eight thousand eight hundred and seventy-eight pounds is hereby appropriated out of the Public Works Fund, and shall be transferred to the credit of the State Coal-mines Account. 25
- (b.) On such transfer being made the said railway shall cease to be under "The State Coal-mines Act, 1901," and shall be deemed to be a Government railway duly constructed under the authority of a special Act.
- (c.) There is hereby further appropriated out of the Public Works Fund the sum of eight thousand pounds to be expended by the Minister for Public Works in meeting existing liabilities and completing the said railway and opening it for traffic. 30
- (d.) When the said railway is open for traffic it shall be managed as a Government railway under "The Government Railways Act, 1900," and the provisions of that Act and the regulations thereunder shall apply accordingly. 35
