A BILL INTITULED

AN ACT to vest in the Mayor, Councillors, and Title. Citizens of the City of Auckland certain Endowments and Reserves in the said City.

 γ HEREAS the several allotments of land described in the First Preamble. Schedule to this Act were, on the sixteenth day of March, one thousand eight hundred and fifty-eight, granted by His Excellency the Governor under the powers conferred on him by an Act of the General

- Assembly of New Zealand, intituled "The Public Reserves Act, 1854," to the Superintendent of the Province of Auckland and his successors, upon trust for the improvement and benefit of the City of Auckland: And whereas the inhabitants of the City of Auckland have since been created a Corporation under the name of "The
- 10 Mayor, Councillors, and Citizens of the City of Auckland": And whereas it is expedient that the said allotments of land should now be transferred to the said Corporation, with the powers hereinafter mentioned: And whereas it is also expedient that the several allotments of land, being Public Reserves described in the Second Schedule to
- 15 this Act, should be vested in the said Corporation, for the purposes hereinafter mentioned.

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :-

1. The Short Title of this Act shall be "The Auckland City Short Title. 20Endowments and Reserves Act, 1875."

Schedules.

2. All the land described in the First and Second Schedules to this Act are hereby vested for an estate in fee simple in "The Mayor, Councillors, and Citizens of the City of Auckland, and their successors, as an endowment for the improvement and benefit of the said city.

3. The Mayor, Councillors, and Citizens, in respect of the lands described in the said *First* Schedules, and any other lands for the time being held by them under the provisions of this Act, may from time to time exercise all or any of the powers following :--

- (1.) May sell-the said lands or any of them.
- (2.) May exchange for other lands in fee simple, and either-pay-or receive money for equality of exchange.
- (3.1.) May raise money by mortgage or debenture with or without power of sale, and subject to and with such powers covenants and stipulations as they may think fit.
- (4.2.) May demise or lease for any term not exceeding ninetynine years, without fine or foregift, or let from year to year or otherwise, and with or without special conditions.
- (5.3.) May lay out roads through the said lands.
- (6.4.) May dedicate any part or parts of such lands for public 20 or for recreation purposes.
- (5.) Provided that no person shall be liable to see to the application of any money paid by him, or accountable for the mis-application or non-application thereof.

Erase Clause 4.

4. All money received from sales and by way of equality of exchange shall be, as soon as conveniently may be, invested in the purchase of other lands in fee simple, and all lands so purchased shall be subject to the provisions of this Act in like manner as though the same had been included in the said Scbedules: Provided that no persons purchasing exchanging mortgaging or leasing shall be liable to see to the application of any money paid by him, or accountable for the misapplication or non-application thereof.

New Clause 4.

- (1.) May enclose lay out and plant the same or any part thereof.
- (2.) May erect any buildings for ornamental purposes, but not for making a profit therefrom.

5. Nothing in this Act contained shall prejudicially affect any lease, mortgage, or other encumbrance heretofore made and now subsisting in respect of the said lands or any of them, nor shall impair or prejudicially affect the provisions of an Act of the Provincial Council of Auckland intituled "The City of Auckland Loan Empowering Act, 45 1874," whereby the said Corporation is authorized to borrow the sum of fifty thousand pounds, nor any thing whatever done or authorized to be done under the said Act or under the powers thereby conferred.
