AN ACT to empower the Auckland City Council to ^{Title.} expend certain Compensation-moneys, paid to it on the taking under the Public Works Act, 1928, of Part of the Land known as the Auckland City Market Site, in the Erection of a Municipal Administrative Block for the City of Auckland.

WHEREAS certain land vested in the Corporation of Preamble. the Mayor, Councillors, and Citizens of the City of
