EXPLANATORY NOTE

Section 27 (6) of the Agriculture (Emergency Powers) Act 1934 provides that all regulations under that Act laid before Parliament in any session shall expire on the close of the last day of the session except so far as they are expressly validated or confirmed by an Act of Parliament passed during that session.

The regulations specified in the Schedule to this Bill have been made under that Act and laid before Parliament this session, and the purpose of this Bill is to validate and confirm them.
