A BILL INTITULED

An Act to transfer certain Land in the City of Auckland, being Title. Part of the Auckland Gaol Reserve, to the Auckland Grammar School Board as a Site for a Secondary School.

5 WHEREAS the land described in the Schedule hereto is part of Preamble. the Auckland Gaol Reserve, but is no longer required therefor: And whereas it is desired to transfer the said land to the Auckland Grammar School Board as a site for a secondary school on the terms and conditions hereinafter appearing:

10 BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:-

1. This Act may be cited as the Auckland Grammar School Site Short Title. Act, 1911.

2. The land described in the Schedule hereto is hereby vested Land vested in in the Auckland Grammar School Board, in trust as a site for a Auckland Grammar School Board. secondary school, subject to the provisions of this Act.

3. (1.) The said Board shall cause to be erected on the said Board to erect land buildings suitable and necessary for the purposes of such school, buildings for secondary school.

20 to the satisfaction of the Minister of Education.

(2.) No building shall be erected on the said land except accord-

ing to plans and in a manner approved by the said Minister.

(3.) Unless within ten years from the passing of this Act the said Board has erected buildings as aforesaid, the Governor may by 25 Proclamation resume possession of such land, and the land shall, as from the date of that Proclamation, revert to the Crown.
