This Public Bill originated in the House of Representatives, and having this day passed as now printed is transmitted to the LEGISLATIVE COUNCIL for its concurrence.

A BILL INTITULED

An Act to authorize the Auckland Harbour Board to raise by way of Title. loan the sum of one hundred and fifty thousand pounds in addition to the sum of one hundred and fifty thousand pounds authorized to be raised by "The Auckland Harbour Act, 1874."

WHEREAS by "The Auckland Harbour Act, 1874," the Auckland Preamble. Harbour Board was authorized to raise money for the purpose of constructing Harbour Works provided for by the said Act and for that purpose to issue debentures for any sum not exceeding in the aggregate 10 the sum of one hundred and fifty thousand pounds, and by the said

Act it was further provided that the debentures to be issued by the said Board in respect of the said money so to be raised should be a first charge on the rents of the land and hereditaments specified in the Third Schedule to the said Act, and on all rates which should be pay-

15 able in respect of any wharf or dock thereon:

And whereas the said Harbour Board, in pursuance of the powers so vested in it has raised the sum of one hundred and fifty thousand pounds and issued debentures for the same, and the sum of one hundred and forty-five thousand three hundred pounds is now owing 20 by the said Board and charged and chargeable as aforesaid. whereas the said Auckland Harbour Board is desirous of constructing a graving dock in the Harbour of Auckland and certain other harbour works, and in order to raise money for that purpose are desirous of borrowing a further sum not to exceed the sum of one hundred and 25 fifty thousand pounds. and to give as security therefor all those lands and securities mentioned in the Second Schedule hereto.

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same as follows:-

1. The Short Title of this Act is "The Auckland Harbour short Title.

Board Empowering Act, 1882."

2. It shall be lawful for the Auckland Harbour Board from time Power to Auckland to time to borrow by debentures in the form in the Third Schedule Harbour Board to borrow further sum hereto, for a period of thirty-five years from the passing hereof, in of £150,000. 35 addition to the said sum of one hundred and fifty thousand pounds authorized to be borrowed by the said "Auckland Harbour Act, 1874," such sum or sums of money not exceeding the sum of one hundred No. 23-3.

and fifty thousand pounds, at a rate of interest not exceeding five pounds per centum per annum, as the said Board may require, for the construction of the harbour works specified in the First Schedule

Payment of debentures.

3. The said debentures together with interest shall be a first 5 charge on the land and hereditaments in the Second Schedule hereto. and the rents thereof, and the dues chargeable and receivable by the said Board in respect of the said lands and the harbour works constructed thereon, and the Harbour Fund of the Harbour of Auekland. subject to the charge created by the first named loan of one hundred and 10 fifty thousand pounds, subject to the hereinbefore mentioned first charge of one hundred and fifty thousand pounds already borrowed, shall be a second charge on the Auckland Harbour Fund as defined by section one hundred and seventy-one of "The Harbours Act, 1878."
