A BILL INTITULED

AN ACT to amend "The Auckland Harbour Board Loan and Empowering Act, 1904." Title.

WHEREAS by an Act entitled "The Auckland Harbour Board Loan and Empowering Act, 1904" (hereinafter referred to as "the said Act"), it was enacted *inter alia* that it should be lawful for the Auckland Harbour Board (hereinafter termed "the Board") from time to time as it might require to borrow by debentures in the form or to the effect in the Second Schedule to the said Act, for a period of twenty years from the issue thereof, the sum of four hundred thousand pounds; and that the said sum, or so much thereof as might be required for the purpose, should be applied and expended in the construction of the harbour-works specified in the First Schedule to the said Act: And whereas the Board is desirous of varying the amounts authorised by the said Act to be expended in the construction of certain of the works specified in the First Schedule to the said Act, and of eliminating for the present certain other works therein specified: Preamble.

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Auckland Harbour Board Loan and Empowering Act 1904 Amendment Act, 1905." Short Title.

2. The First Schedule to the said Act is hereby repealed.

3. The Schedule to this Act shall be deemed to be the First Schedule to the said Act, and the said Act shall be read and construed accordingly. Repeal.

Should it hereafter be found necessary to expend more moneys than those mentioned opposite the several works shown in the Schedule hereto upon the construction, extension of, or addition to any of such works, or to expend any moneys raised under the said Act upon any works which the Board may be now or hereafter entitled to construct or effect, such portions of the moneys now or hereafter raised under the said Act as the Board may consider necessary may be applied to such construction, extension, or additions, or upon such other works as aforesaid. 5

5. Nothing in this Act contained shall authorise the construction of any harbour-works except subject to the provisions of "The Harbours Act, 1878," and its amendments. 10
