A BILL INTITULED

AN ACT to provide for the Establishment and Manage-Title. ment of the Ashburton High School.

WHEREAS it is expedient and desirable to make special provision Preamble. for the establishment and management of a High School to be established within the Education District of North Canterbury, at Ashburton, in the County of Ashburton :

BE IT THEREFORE ENACTED by the General Assembly of New 5 Zealand in Parliament assembled, and by the authority of the same, as follows :-

1. The Short Title of this Act shall be "The Ashburton High short Title. School Act, 1878."

- 2. The Board of Governors, to be composed and appointed as Board of Governors 10 hereinafter provided, shall be and is hereby constituted a body to be appointed and incorporated. corporate by the name of the Ashburton High School Board (hereinafter called "the said Board"), by which name such body corporate shall have a perpetual succession and a common seal, and may hold
- 15 lands, and may sue and be sued, and may do and suffer all such things as corporate bodies may do and suffer. 3. The said Board shall consist of seven persons, of whom one Constitution of Board shall be the Mayor for the time being of the Borough of Ashburton,

two shall be nominated from time to time by the County Council of 20 Ashburton, two shall be nominated and appointed from time to time

- by the Governor, and two shall be elected annually by the Board of Education for North Canterbury; and no member shall hold office longer than a year, but a retiring member shall be eligible for election or nomination.
- 4. If any member of the said Board shall cease to reside within Governors to vacate 25the Provincial District of Canterbury for a period of six months, or office in certain cases. shall by writing under his hand resign his office, or become bankrupt, or be convicted of any indictable offence, he shall immediately thereupon cease to be a member of such Board.
- In the event of any vacancy or vacancies occurring by reason of 30 the death, resignation, or otherwise of the elected members of the said Board, such vacancy or vacancies may forthwith be filled up by the election of a new member or members by the said Education Board of the District of North Canterbury, or by the nomination of the Gover-No. 147-3.

nor, or of the County Council of Ashburton, according as the vacancy shall have occurred in the case of a member who has been elected by the said Education Board, or nominated by the Governor, or by such County Council.

5. The said Board shall meet for the first time at such time and 5 place as the Governor shall, by Proclamation in the *New Zealand Gazette*, appoint, and shall forthwith proceed to elect a Chairman, who shall preside at all meetings of the Board at which he shall be present during the year next after his election, and when so presiding shall have a deliberative and a casting vote on all questions coming 10 before the Board; and such Chairman shall have the custody of the common seal.

6. The said Board shall make and may from time to time revoke, vary, and make fresh regulations for the conduct of business at their meetings, for determining how meetings shall be convened, and what 15 number of members shall constitute a quorum thereat, and for such other like matters as may be requisite for the conduct of the business of the said Board.

7. Minutes of the proceedings of the said Board shall be regularly entered in a proper book to be kept for that purpose, and at every 20 meeting of the said Board the minutes of the previous meeting shall be read over and signed by the Chairman of the meeting at which the same shall be read, and the minutes when so signed shall be held to be a true statement and record of the proceedings of the Board for all purposes whatsoever. 25

8. The Board shall keep full and accurate accounts of all their receipts, disbursements, assets, liabilities, and engagements, and shall, in the month of *January* in each year, cause the same to be audited by such person as the Governor in Council may appoint; and copies of such accounts, when audited, shall be forwarded to the Minister in 30 charge of the Department of Education, together with a report of the proceedings of the said Board during the previous year; and such report and accounts shall be laid before the Assembly at its next session.

9. All things required by this Act to be done by the said Board 35 shall be done in accordance with or in pursuance of a resolution passed at a meeting of the said Board, and no act of the said Board shall be invalid or liable to be questioned on the ground that one or more of the members of the said Board was or were incapacitated, or had ceased to hold office as members of the said Board. 40

10. All real and personal estate which may be purchased by the Board or granted as a site or sites for a High School, devised, bequeathed, or given to the said Board for the benefit of the Ashburton High School without any trusts of a different nature being expressed, shall be held by the said Board upon trust for the general 45 purposes of this Act.

11. The said Board shall have power with respect to all lands that may be vested in them by virtue of this Act to manage the same as they may see fit, and from time to time to let the same or any part thereof for any term not exceeding twenty-one years 50 from the time when such lease shall be made, at such rent and on such terms and conditions as they shall think fit: Provided that every such lease shall be put up to public competition by auction of which one months' previous notice shall have been given by public advertisement within the district in which the land about to be leased 55 shall be situated: And provided also that no fine, premium, or foregift shall be taken by the said Board in respect of any such lease.

12. The rents, profits, and annual income of all real and personal estate which may be vested in the said Board, together with all funds which may from time to time be derived from fees or payments made 60 in respect of scholars or students attending the said High School, shall

- 5 if they shall see fit, out of the said rents, profits, and annual income, such part as they shall consider advisable, either as addition to the capital fund, which shall then be invested in manner as hereinafter mentioned and dealt with as part of such capital fund, or as a reserve fund to meet extraordinary expenses, which shall be invested and 10 dealt with in such manner as the said Board shall direct.
- 13. With respect to any moneys bequeathed or given to the said Board may invest Board for the said High School, or being rents, profits, and annual moneys not required for annual expendiincome set apart under the preceding section, the said Board shall have ture. power to invest the same in the purchase or upon mortgage of freehold 15 lands in New Zcaland, or upon the stocks, bonds, bills, or debentures
- of the Government of the Colony of New Zealand, or of any Municipal Corporation established within such colony, and from time to time to
- vary any such investment.
 14. The said Board may, out of such moneys as shall come into Application of the moneys. 20 their hands by virtue of this Act or otherwise for the benefit of the Ashburton High School, expend any sum or sums not exceeding on the whole ten thousand pounds in erecting suitable buildings and premises for use as a High School.
- 15. There shall be vested in the Board the whole control and Board to have control 25 management of the Ashburton High School, and the said Board shall have full power to appoint and dismiss all professors, masters, teachers, for conducting the lecturers, examiners, and other officers and servants for the management of the said High School, and also the entire management and superintendence over all the affairs, concerns, and property of the said
- 30 High School; and, in all cases unprovided for by this Act, it shall be lawful for the said Board to act in such manner as shall appear to them best calculated to further the purposes intended to be served by the establishment of a High School: And the said Board shall have full power from time to time to make by-laws and regulations for defining
- 35 the course of study and education on secular subjects in the said High School, and also for the discipline and examination of the same, the conditions upon which scholars shall be admitted, and the fees to be paid in respect of such admission, and in general touching all other matters, purposes, and things regarding the said High School.
- 40 16. It shall be lawful for the Commissioners appointed under Reserves, how "The Education Reserves Act, 1877," for the Provincial District of granted. Canterbury, or, if they fail to act, for two Commissioners appointed for that purpose by the Governor, to select out of the reserves for secondary education in the Provincial District of Canterbury such
- 45 reserves as will be equal to one-tenth of the whole value of the said reserves, to be ascertained in manner following: The said Commissioners shall, within six months after the passing of this Act, make a valuation of the whole of the said reserves for secondary education in the said provincial district, and shall determine which of such reserves
- 50 shall be of a value equal to one-tenth of the whole value thereof, and shall set apart the reserves last aforesaid for the maintenance of the Ashburton High School: Provided--always-that-the-reserves so-set apart shall, as nearly as pessible, be selected out of that part of the whole reserves-for-secondary-education-which-are-situated-within-the-Education
- 55 District of Canterbury; and, on the Proclamation of the Governor that such reserves have been selected and set apart for the said Ashburton High School, the said reserves shall absolutely vest in the Ashburton High School Board incorporated by this Act.
- 17. The Ashburton High School shall be subject to inspection by Inspection. 60 an Inspector appointed by the Minister of Education.
