A BILL INTITULED

An Act to amend the Aircrew Industrial Tribunal Act 1971

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Aircrew Industrial Tribunal Amendment Act 1985, and shall be read together with and deemed part of the Aircrew Industrial Tribunal Act 1971* (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1985.

2. Interpretation—(1) Section 2 of the principal Act is hereby amended by inserting, after the definition of the term "airline employer", the following definition:

"'Authorised representative, in relation to any union of 15 aircrew officers, means a person authorised in accordance with the rules of the union, or by its committee of management, to act on its behalf:".

(2) Section 2 of the principal Act is hereby further amended by repealing the definition of the term "conditions of 20 employment" (as substituted by section 2 (1) of the Aircrew Industrial Tribunal Amendment Act 1983), and substituting the following definition:

" 'Conditions of employment'—

"(a) Means all matters pertaining to the 25 remuneration or other terms or conditions of service or employment of, or affecting or relating to work done or to be done by, aircrew officers employed or to be employed by airline employers; and

"(b) Includes—
"(i) All matters affecting the privileges, rights, and
duties of unions of aircrew officers or of
the officers of any union of aircrew

"(i) Any preference on obtaining or retaining employment; or

"(ii) Any preference in relation to terms of employment or conditions of employment or fringe benefits or opportunities for training, promotion, or transfer; or

"(iii) Any preference in relation to the formula that will be used to assess compensation for redundancy:".

(3) Section 2 of the principal Act is hereby further amended by repealing the definition of the term "society of aircrew 20 officers" (as inserted by section 2 (2) of the Aircrew Industrial Tribunal Amendment Act 1983).

(4) Section 2 of the principal Act is hereby further amended by inserting, after the definition of the term "Tribunal", the following definitions:

"'Union membership clause', in relation to any award or to any record certified under section 30 of this Act, means a clause which is included or is deemed to be included in the award or record and which provides as follows:

"'If any (person (other than an apprentice or) adult person (other than a person who holds a certificate of exemption from union membership issued under section 1120 of the Industrial Relations Act 1973) who is not a member of a union of aircrew officers is engaged or employed by any airline employer, in any position or employment that is subject to the award or record, the person shall become a member of the union of aircrew officers within 14 days after that person's engagement or, as the case may require, after this clause comes into force, and shall remain a member of the union of aircrew officers so long as that person continues in the position or employment.':

"'Union Membership Exemption Tribunal' means the Union Membership Exemption Tribunal established by section 105 of the Industrial Relations Act 1973:".

(5) Section 2 of the principal Act is hereby amended by adding, as subsections (2) and (3), the following subsections:

"(2) For the purposes of both the definition of 'union membership clause' in subsection (1) of this section and sections 5A to 5s of this Act, 'adult person' means—

- such a clause shall, as from the beginning of the 14th day after 35 the date of that certificate and throughout the balance of the period of 3 years beginning with the date of the certificate, be inserted by the Tribunal in each of the awards and in each of the records certified under section 30 of this Act by which members of the union are bound from time to time.
- 40 "(2) Where—
 - "(a) The Registrar of Industrial Unions certifies that more than 50 percent of the valid votes recorded in any

ballot conducted pursuant to the rules included, or deemed to be included, by section 5B of this Act, in the rules of the union are not in favour of the insertion of a union membership clause in each of the awards and in each of the records certified under section 30 of this Act by which members of the union are bound from time to time; and

"(b) At the date of the certificate a union membership clause is not inserted or deemed to be inserted in each of the awards and in each of the records certified under 10 section 30 of this Act by which members of the union are then bound,-

a union membership clause shall not, at any time in the period of 3 years beginning with the date of the certificate, be inserted in each of the awards and in each of the records certified under section 30 of this Act by which members of the union are bound.

"5E. Power to make consequential amendments to award or record—(1) Where, as the result of any ballot conducted pursuant to the rules included, or deemed to be included, by 20 section 5B of this Act, in the rules of the union, a union membership clause is required to be inserted in any award or in any record certified under section 30 of this Act, the Tribunal shall, where necessary, amend the award or record by inserting in it a union membership clause.

"(2) Where the Tribunal is satisfied that there is no authority for the continued insertion of a union membership clause in any award or in any record certified under section 30 of this Act, the Tribunal (may) shall amend that award or record by deleting that clause from it.

"5F. Explanatory note in relation to expiry of union membership clause—Where a union membership clause is inserted, or deemed to be inserted, in an award or in any record certified under section 30 of this Act, the Tribunal shall ensure that the award or record contains an explanatory note 35 stating the date on which the clause will expire unless in a ballot, which is conducted after the insertion or deemed insertion of that clause and which is so conducted pursuant to the rules included, or deemed to be included, by section 5B of this Act in the rules of the union, not less than 50 percent of 40 the valid votes recorded are in favour of the union membership clause.

"5G. Insertion of union membership clause in award or record to which 2 or more unions are parties—Where 2 or more unions are parties to an award or to a record certified under section 30 of this Act and not all of those unions are entitled to have a union membership clause inserted in the award or record, the explanatory note required by section 5F of this Act shall state, in addition to the matters required by that section, the names of the unions excluded from the union membership clause.

"5H. Notice to Registrar—(1) Where a union intends to conduct a ballot pursuant to the rules included, or deemed to be included, by section 5B of this Act in its rules, the committee of management of the union shall, at least 30 days before the day on which the special meeting or the first of the series of special meetings required is held, give or post to the Registrar of Industrial Unions written notice of that intention in form 3 in Schedule 1B to the Industrial Relations Act 1973, which notice shall state, among other things, the date, time, and place of each special meeting.

"(2) For the purposes of this section, form 3 in Schedule 1B to the Industrial Relations Act 1973 shall, subject to subsection (3) of this section, apply with all necessary modifications.

"(3) Notwithstanding anything in subsection (1) or subsection 25 (2) of this section, regulations made under section 50 of this Act may prescribe a form (based on form 3 in Schedule 1B to the Industrial Relations Act 1973) that shall apply for the purposes of subsection (1) of this section in the place of that form.

30 "51. Conduct of ballot—(1) Every ballot conducted pursuant to the rules included or deemed to be included by section 5B of this Act in the rules of a union shall be conducted by the union under the supervision of the Registrar of Industrial Unions, or of some person, being an officer of the Department of Labour, designated by the Registrar to supervise that ballot.

"(2) The ballot paper shall be in form 4 in Schedule 18 to the Industrial Relations Act 1973.

"(2A) The Returning Officer shall, at the conclusion of the special meeting or, where there is a series of special meetings, at the conclusion of that series, prepare, and make available to the Registrar and to any voter or other interested person, a record showing—

"(a) The number of votes in favour of the union membership

"(b) The number of votes against the union membership clause:

10

"(c) The number of informal votes.

"(3) The Registrar of Industrial Unions shall issue a certificate showing the result of the ballot, which certificate shall be in form 5 in Schedule 18 to the Industrial Relations Act 1973, and shall supply one copy of that certificate to the Tribunal 15 and another to the union. Every such certificate shall be conclusive evidence of the result of the ballot.

"(4) The expenses incurred by the Registrar or designated person in connection with the conduct of every such ballot shall be paid out of money to be appropriated by Parliament 20 for the purpose.

"(5) Notwithstanding anything in the rules of the union the Registrar or designated person may take such action and give such directions as he considers necessary to prevent the occurrence of any irregularity in or in connection with the ballot.

"(6) In this section the term 'designated person' means any person designated under subsection (1) of this section to supervise the ballot on behalf of the Registrar.

"(7) For the purposes of this section, forms 4 and 5 in Schedule 30 18 to the Industrial Relations Act 1973 shall, subject to subsection (8) of this section, apply with all necessary modifications.

"(8) Notwithstanding anything in subsections (2), (3), and (7) of this section, regulations made under section 50 of this Act may prescribe forms (based on forms 4 and 5 in Schedule 1B to the 35 Industrial Relations Act 1973) that shall apply for the purposes of subsections (2) and (3) of this section respectively in the place of those forms.

"5J. **Restriction on issue of certificates**—(1) The Registrar of Industrial Unions shall not issue a certificate showing the 40 result of a ballot conducted under the rules included, or deemed

to be included, by section 5B of this Act in the rules of a union if, during the 3 years preceding the date on which it was conducted, a certificate showing the result of an earlier ballot conducted under the rules so included or deemed to be 5 included, was issued by the Registrar of Industrial Unions.

"(2) Where—

"(a) A union conducts a ballot pursuant to the rules included, or deemed to be included, in its rules by **section 5B** of this Act; and

10 "(b) A period of more than 2 years but less than 3 years has elapsed since the date on which a certificate was last issued by the Registrar of Industrial Unions in respect of a ballot conducted by that union pursuant to the rules so included or deemed to be included,—

15 the Registrar shall postpone the issue of the certificate in respect of the latest ballot until immediately after the expiration of the period of 3 years specified in subsection (1) of this section.

"5K. Offences in relation to ballots—(1) Every person commits an offence who, without lawful authority or excuse, 20 in or in connection with a ballot conducted pursuant to the rules included, or deemed to be included, by section 5B of this Act in the rules of any union—

"(a) Personates another person to secure a ballot paper to which the personator is not entitled, or personates

another person for the purpose of voting:

"(b) Destroys, defaces, alters, takes, or otherwise interferes with a ballot paper or envelope:

"(c) Puts a ballot paper or other paper into a ballot box or other ballot receptacle or into the post:

"(d) Records a vote which that person is not entitled to record.

"(2) Every person commits an offence who—

"(a) Gives any money or other valuable consideration to any person entitled to vote in the ballot in order to induce any such person to vote or refrain from voting; or

"(b) Refuses or fails to comply with a direction of the Registrar or the designated person under section 51

of this Act; or

40 "(c) Obstructs or hinders the Registrar or the designated person in the taking of any action under section 51 of this Act or any person in the carrying out of a direction given by the Registrar or the designated person under that section; or

"(d) Intimidates or attempts to intimidate any ((worker)) person with intent to influence the ((worker's)) person's voting in the ballot. "(3) Every person who commits an offence against this section shall be liable on summary conviction to a fine not exceeding \$500.

"5L. **Applications for inquiries—**(1) Where, in the case of a ballot conducted under the rules included, or deemed to be included, by section 5B of this Act in the rules of any union not less than 10 percent or 50 of the persons eligible to vote 10 in the ballot (whichever is the smaller number) claim—

"(a) That the rules so included or deemed to have been so included have not been complied with by the union;

"(b) That notwithstanding the rules included or deemed to 15 be so included, the special meeting or special meetings of the union did not constitute an adequate opportunity for the persons eligible to vote in that ballot to attend the meeting or meetings and to vote;

"(c) That there has been an irregularity in or in connection with the conduct of the ballot,—

they may apply to the Registrar of Industrial Unions for an inquiry into the matter.

"(2) An application under this section shall—

"(a) Be in writing in form 6 in Schedule 1B to the Industrial Relations Act 1973:

"(b) Be lodged with the Registrar of Industrial Unions:

"(c) Specify-

"(i) The ground or grounds relied on under 30 **subsection** (1) of this section:

"(ii) The non-compliance (if any) in respect of which the application is made or the irregularity (if any) which is claimed to have occurred:

"(d) State the facts relied on in support of the application:

"(e) Be accompanied by a statutory declaration by one of the applicants that the facts stated in the application are, to the best of the applicant's knowledge and belief, true:

"(f) Be made during the period of 30 days beginning with 40 the date on which the Registrar of Industrial Unions certifies the result of the ballot.

"(3) For the purposes of this section, form 6 in Schedule 1B to the Industrial Relations Act 1973 shall, subject to subsection (4) of this section, apply with all necessary modifications.

5 "(4) Notwithstanding anything in subsection (2) or subsection (3) of this section, regulations made under section 50 of this Act may prescribe a form (based on form 6 in Schedule 1B to the Industrial Relations Act 1973) that shall apply for the purposes of subsection (2) of this section in the place of that 10 form.

"5M. Action by Registrar of Industrial Unions—Every application under section 5L of this Act shall be dealt with by the Registrar of Industrial Unions as if it were an application under section 102D of the Industrial Relations Act 1973, and the provisions of sections 102E to 102G of that Act shall, with all necessary modifications, apply accordingly.

"5N. Ballot papers, etc., to be preserved—
(1) Notwithstanding anything in the rules of the union, that union and every officer of that union or a branch of that union 20 who is able to do so shall take all reasonable steps to ensure that all ballot papers, envelopes, lists, and other documents used in connection with, or relevant to, a ballot conducted under the rules included, or deemed to be included, by section 5B of this Act in the rules of the union are preserved and kept 25 at the registered office of the union for a period of one year after the completion of the ballot.

"(2) Every union or officer that fails to comply with subsection (1) of this section commits an offence against this Act.

"50. Enforcement of union membership clauses—30 (1) Where pursuant to this Act a union membership clause is inserted in an award or in a record certified under section 30 of this Act, the following provisions shall apply:

"(a) Every aircrew officer to whom the union membership clause applies shall be liable to a penalty not exceeding (\$500) \$50 if that aircrew officer fails to become a member of the union in accordance with that clause, after having been requested to do so by any officer or authorised representative of the union, or if, having become a member of the union, that aircrew officer fails to remain a member in accordance with that clause:

"(b) Every airline employer who is bound by the award or record shall be liable to a penalty not exceeding (\$1,500) \$500 if the airline employer continues to employ any airline officer, being an airline officer to whom that clause applies, after having been 5 notified by any officer or authorised representative of the union that the airline officer has been so requested to become a member of the union and has failed to become a member in accordance with that clause, or that the person after having become 10 a member of the union, has failed to remain a member in accordance with that clause.

"(2) The Tribunal shall have full and exclusive jurisdiction to deal with all actions for the recovery of penalties under this section.

15

"(3) For the purposes of this section, every reference to the Tribunal shall be read as a reference to the Chairman of the Tribunal acting alone.

"(4) A penalty recoverable under this section shall be recovered in the same manner, with all necessary modifications, 20 as a penalty for a breach of an award under the Industrial Relations Act 1973; and sections 151 to 157 of that Act (except subsections (1), (5), and (6) of section 151) shall apply accordingly with all necessary modifications.

"(5) An action for the recovery of a penalty under this section 25

may be brought only by the union.

"(6) The Tribunal may delegate to any District Court Judge named by it its powers and functions to deal with an action under this section and the provisions of section 49 of the Industrial Relations Act 1973 (except those of subsection (6)) 30 shall, with all necessary modifications, apply accordingly.

"5P. Application for exemption from membership of union—(1) Any person who is required by a union membership clause to become or to remain a member of a union may apply to the Secretary of the Union Membership 35 Exemption Tribunal for a certificate of exemption from union membership.

"(2) The Union Membership Exemption Tribunal shall have, in addition to its other functions, the function of considering and determining every application made under subsection (1) 40 of this section and the provisions of sections 111, 112c to 1121, and 112k to 112a of the Industrial Relations Act 1973 shall apply accordingly with all necessary modifications.

"5Q. Intervention by other unions or central organisation of workers—(1) Where any other union or the central organisation of workers considers that it has an interest in the hearing of an application under section 5p (1) of this Act, it may apply to the Secretary of the Union Membership Exemption Tribunal for the union's or organisation's secretary or any other person appointed in that behalf to also be present and be heard at the hearing.

"(2) The Secretary of the Union Membership Exemption
10 Tribunal shall refer every application under this section to the
Union Membership Exemption Tribunal, which shall
determine, before the hearing, whether or not the union or
the central organisation of workers has such an interest in the
hearing as would justify the union's or central organisation's
15 secretary or other person so appointed being entitled to be
present and to be heard.

"5R. **Discrimination**—(1) It shall be unlawful for an airline employer—

"(a) Other than by the lawful insertion in any award or any record certified under section 30 of this Act of a union membership clause, to make membership of a union of aircrew officers a condition to be fulfilled by any person who wishes to obtain or retain any position or employment; or

"(b) To make non-membership of a union of aircrew officers a condition to be fulfilled by any person who wishes to obtain or retain any position or employment; or

"(c) To exert undue influence on any aircrew officer with intent to induce that aircrew officer—

"(i) To become or remain a member of a union of aircrew officers; or

"(ii) To cease to be a member of a union of aircrew officers; or

35 "(iia) Not to become a member of a union of aircrew officers; or

"(iii) On account of the fact that the aircrew officer is, or, as the case may be, is not, a member of a union of aircrew officers, to resign from any position or to leave any employment.

"(2) No union and no officer or other person acting on behalf of any union (whether lawfully authorised to do so or not) shall exert undue influence on any person with intent to induce that person"(a) To join a union; or

"(b) On account of the fact that that person is not a member of a union, to resign any position or to leave any employment.

"(3) Every person who contravenes subsection (1) or subsection

(2) of this section shall be liable,—

"(a) If an officer of a union or person acting on behalf of a union (whether lawfully authorised to do so or not), to a penalty not exceeding \$500:

"(b) If a union or employer, to a penalty not exceeding 10

\$1,500.

"(4) The Tribunal shall have full and exclusive jurisdiction to deal with all actions for the recovery of penalties under this section.

"(5) For the purposes of this section, every reference to the 15 Tribunal shall be read as a reference to the Chairman of that

Tribunal acting alone.

"(6) A penalty recoverable under this section shall be recovered in the same manner, with all necessary modifications, as a penalty for a breach of an award under the Industrial 20 Relations Act 1973; and sections 151 to 157 of that Act (except subsections (1), (5), and (6) of section 151) shall apply accordingly with all necessary modifications.

"(7) An action for the recovery of a penalty in respect of an alleged contravention of subsection (1) or subsection (2) of this 25 section may be brought only by the person or aircrew officer in relation to whom the contravention is alleged to have taken

place.

"(8) Nothing in this section renders unlawful the enforcement of a union membership clause that is included or deemed to 30 be included in any award or in any record certified under section 30 of this Act.

"5s. Right of aircrew officers to become members of unions—Every person who, by virtue of that person's employment or intended employment, is within the categories of aircrew officers to which a union of aircrew officers is constituted, and who is not of general bad character, shall be entitled to become a member of that union of aircrew officers on application made in accordance with its rules; and, so far as the rules of any union of aircrew officers are inconsistent 40 with this section, they shall be of no effect."

4. Repeal—Section 2 of the Aircrew Industrial Tribunal Amendment Act 1983 is hereby repealed.

5. Transitional provision in respect of union membership clauses—(1) This section applies in respect of—

(a) Any award or any record certified under section 30 of this Act which is in force on the commencement of this Act and which has superseded an award or record that contained a union membership clause and was in force immediately before the 1st day of February 1984 (the date of commencement of the Aircrew Industrial Tribunal Amendment Act 1983):

10 (b) Any award or any record certified under section 30 of this Act which is made after the commencement of this Act and which supersedes an award or record that contained a union membership clause and was in force immediately before the 1st day of February 1984 (the date of commencement of the Aircrew Industrial Tribunal Amendment Act 1983):

(c) Any award or any record certified under section 30 of this Act which is in force on the commencement of this Act and which came into force in the period beginning on the 1st day of February 1984 and ending with the commencement of this Act:

(d) Any award or any record certified under section 30 of this Act which comes into force on the date of the commencement of this Act.

25 (2) Every award or record to which this section applies by virtue of paragraph (a) or paragraph (b) or paragraph (c) of subsection (1) of this section shall, throughout the period of 18 months beginning on the (commencement of this Act) 1st day of July 1985, be deemed to contain, so long as that award or record 30 continues in force, a union membership clause.

(3) Every award or record to which this section applies by virtue of paragraph (d) of subsection (1) of this section shall, throughout the period beginning with the date on which it comes into force and ending on the expiry of the period of 35 18 months beginning on the date of the commencement of this Act, be deemed to contain, so long as that award or record continues in force, a union membership clause.

(4) The Tribunal may amend any award or record to which this section applies by inserting in it the union membership do clause deemed, by subsection (2) or subsection (3) of this section, to be contained in it.

(4A) Notwithstanding anything in subsections (2) to (4) of this section, where, at any time in the period specified in subsection (2) of this section, a ballot is conducted pursuant to the rules included, or deemed to be included, by section 5B (1) of the principal Act in the rules of any union of aircrew officers,—

(a) Âny union membership clause deemed by subsection (2) or subsection (3) of this section to be contained in an award or any record certified under section 30 of the principal Act by which members of the union are 10 bound shall cease to have effect on the day following the date of the certificate by which the Registrar of Industrial Unions certifies, under section 51 of the principal Act the result of the ballot; and

(b) Subsection (3) of this section shall not have effect in respect 15 of any award or any record certified under section 30 of the principal Act (being an award or record which binds members of the union and which comes into force after the date of the certificate by which the Registrar of Industrial Unions certifies, under 20 section 51 of the principal Act, the result of the ballot).

(5) This section shall have effect notwithstanding anything in the principal Act.

6. Transitional provision relating to obligatory rule 25 concerning union membership clauses—Notwithstanding the provisions of subsection (2) of section 5B of the principal Act (as enacted by section 3 of this Act), where the rules set out in subsection (1) of section 5B of the principal Act are deemed to be included in any rules in force at the commencement of this 30 Act, it shall not be necessary to include the rules deemed to be so included in or to supply the rules deemed to be so included with any copy of those rules delivered or supplied before the 1st day of October 1985.
