An Act to amend the Agriculture (Emergency Powers) Title. Act, 1934, and to validate and confirm certain Regulations made thereunder.

5 BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Agriculture Short Title. (Emergency Powers) Amendment Act, 1936, and shall 10 be read together with and deemed part of the Agriculture (Emergency Powers) Act, 1934 (hereinafter referred to 1934, No. 34 as the principal Act).

2. While regulations under the Dairy Industry Act, Regulations 1908, or any other Act, are in force requiring any under principal 15 dairy-produce to be packed in containers of a prescribed impose impose kind, regulations may be made under the principal Act obligations on to ensure that manufacturers or other suppliers of manufacturers of of containers of containers for such dairy-produce shall supply containers dairy-produce.

Penalty for offences against regulations made under authority of principal Act. 3. (1) Every person who commits, or attempts to commit, or does any act with intent to commit, an offence against any regulations made under the principal Act (whether such regulations have been made before or are made after the passing of this Act, and notwithstanding anything to the contrary in such regulations) 10 shall be liable on summary conviction to a fine of two hundred pounds, in the case of an individual, and, in the case of a company or other corporation, to a fine of one thousand pounds.

(2) Any proceedings for an offence against any such 15 regulations may be commenced at any time within three

years after the commission of the offence.

4. The regulations specified in the Schedule to this Act are hereby declared to be valid, and are hereby confirmed as required by section twenty-seven of the 20 principal Act.
