A BILL INTITULED

An Act to validate and confirm certain regulations made under the Agriculture (Emergency Powers) Act 1934

WHEREAS by section 29 of the Agriculture (Emergency
5 Powers) Act 1934 (hereinafter referred to as the Act) it is provided that all regulations made under that section shall be laid before Parliament and shall expire on the close of the last day of the session in which they are laid except so far as they are expressly validated or confirmed by an Act of
10 Parliament passed during that session: And whereas the regulations specified in the First Schedule to this Act were made under the authority of the Act and have been laid before Parliament during the present session, and it is desired to validate and confirm those regulations: And whereas the
15 enactments specified in the Second Schedule to this Act were previously passed to validate or confirm regulations made under the Act:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the

2 *Agriculture (Emergency Regulations Confirmation)*

1. Short Title—This Act may be cited as the Agriculture (Emergency Regulations Confirmation) Act 1977.

2. Regulations confirmed—The regulations specified in the First Schedule to this Act are hereby declared to be valid and are hereby confirmed as required by section 27 of the Act. 5

3. Repeals and savings—(1) The enactments specified in the Second Schedule to this Act are hereby repealed.

(2) The repeal of any such enactment shall not affect the validity of any regulation validated or confirmed by it.
