A BILL INTITULED

AN ACT to vest in the Roman Catholic Bishop of Auckland and his Successors certain Reserves set apart for Roman Catholic Purposes in the Land District of Auckland. Title.

5 WHEREAS the lands described in the Schedule hereto have at various times been set apart for purposes of the Roman Catholic Church, or have been for a long time occupied for such purposes, and it is expedient to vest the same in the Roman Catholic Bishop of Auckland and his successors in trust for the same purposes : Preamble.

10 BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :—

1. The Short Title of this Act is "The Auckland Roman Catholic Reserves Act, 1890." Short Title.

15 2. The lands described in the Schedule hereto are hereby vested in the Right Reverend John Edmund Luck, O.S.B., and his successors, Roman Catholic Bishops of Auckland, for an estate in fee simple, in trust for the purposes for which the said lands were originally reserved or occupied. Reserves vested in Roman Catholic Bishop of Auckland for Church purposes.

20 3. The aforesaid Bishop or his successors may sell or exchange any of the said lands, or part thereof, including any unused part of a cemetery, which shall be found unsuitable for the purposes for which they were originally dedicated, and the proceeds of any such sale shall be applied to the acquisition of other lands, which, as well as any lands acquired in exchange for any of the first-mentioned lands, shall be held by the said Bishop and his successors upon the same trusts as the original lands sold or given in exchange. Unsuitable lands may be sold or exchanged for other lands to be held upon the same trusts.
