A BILL INTITULED

An Acr to amend the Auckland University College Title. Act, 1882.

BE IT ENACTED by the General Assembly of New 5 Zealand in Parliament assembled, and by the authority of the same, as follows:-

1. This Act may be cited as the Auckland University Short Title. College Amendment Act, 1947, and shall be read together with and deemed part of the Auckland 1882 (Local), 10 University College Act, 1882.

2. (1) Section two of the Auckland University Provision for College Amendment Act, 1912, is hereby amended by additional

adding thereto the following new paragraphs:— "(g) One member elected by the members of such represent class or classes of the teaching staff, not teaching staff being professors, as the Council determines; 1912, No. 14 and

- "(h) One member appointed by the Executive Committee of the Auckland University College Students' Association (Incorporated)."
- (2) The said section two is hereby further amended by omitting from the end of paragraph (e) the word 5
- (3) The Auckland University College Council shall as soon as practicable after the passing of this Act, and may from time to time thereafter, determine what class or classes of members of the teaching staff shall 10 be entitled to vote at any election of the member of the Council (hereinafter referred to as the representative of the teaching staff) to be elected pursuant to paragraph (g) of the said section two (as set out in subsection one of this section).

Term of **3.** (1) Except as otherwise provided in this section, the term of office of the members of the Council elected or appointed under this Act shall be two years.

(2) With respect to the first members of the Council to be elected or appointed under this Act the following 20

provisions shall apply:—

(a) The first election of the representative of the teaching staff shall be held as soon as practicable after the passing of this Act, and the member so elected shall come into office on the 25 day of his election:

- (b) The first appointment of a member by the Executive Committee of the Auckland University College Students' Association (Incorporated) shall be made as soon as 30 practicable after the passing of this Act, and the member so appointed shall come into office on the day of his appointment:
- (c) Those members shall retire from office on the first day of July, nineteen hundred and forty- 35
- (3) Section six of the Auckland University College Amendment Act, 1912, is hereby amended by omitting the words "appointed in accordance with paragraphs (e) and (f)", and substituting the words "appointed 40 or elected in accordance with paragraphs (e), (f), (g), and (h)".
