# **EXPLANATORY NOTE**

Clause 2 extends for five years the period within which the provisions of the principal Act apply to land in a bauxite area.

 ${\it Clause}$  3 substitutes a new description of land constituting a bauxite area. All the land described in the substituted Schedule is already in a bauxite area.

#### A BILL INTITULED

### An Act to amend the Bauxite Act 1959

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of 5 the same, as follows:

- 1. Short Title—This Act may be cited as the Bauxite Amendment Act 1964, and shall be read together with and deemed part of the Bauxite Act 1959\* (hereinafter referred to as the principal Act).
- 10 2. Extension of provisions—(1) Subsection (4) of section 3 of the principal Act is hereby amended by omitting the words "nineteen hundred and sixty-five", and substituting the words "nineteen hundred and seventy".
- (2) Subsection (5) of section 3 of the principal Act is 15 hereby amended by omitting the words "nineteen hundred and sixty-five", and substituting the words "nineteen hundred and seventy".

- 3. Definition of bauxite area—(1) The principal Act is hereby amended by repealing the Schedule thereto (as amended by section 2 of the Bauxite Amendment Act 1960) and substituting the new Schedule set out in the Schedule to this Act.

# NEW SCHEDULE TO PRINCIPAL ACT "SCHEDULE

#### BAUXITE AREA

Section 2

ALL that area in the North Auckland Land District, containing an area of 730 square miles, more or less, bounded by a line commencing at a point on the sea coast in Block IV, Russell Survey District, being the north-eastern corner of Taupiri Block; thence southerly along a right line to the south-western corner of Lot 4 of Part Allotment N.E. 43, Hikurangi Parish, containing an area of 4 acres 2 roods and 31 perches, more or less, situated in Block XVI, Hukerenui Survey District; thence north-westerly along a right line to the western corner of Subdivision 32, Kohewhata Block, situated in Block XV, Omapere Survey District; thence northerly along a right line passing through Trig. Station 13, St. Pauls, in Block VII, Whangaroa Survey District, and its production to the sea coast on Whangaroa Bay in Block III, Whangaroa Survey District; thence south-easterly generally along the sea coast to the point of commencement, and including all adjacent islands."
